## ORDINANCE NO. 41 THIRD SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF JACKSON TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated the 3rd day of September, 1980, requesting annexation of the territory hereinafter described was duly presented to the City Council on the 16th day of September, 1980; and

WHEREAS, the quantity of land embraced within the area described in the petition is approximately 5.0 acres of unplatted land, no part of which is included within the limits of any incorporated city, village, or borough; and

WHEREAS, the petition was signed by the owners of all of the land embraced within the area described in the petition; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and the Town Board of Wisconsin Township has filed a waiver of its right to object; and

WHEREAS, the land described in the petition abuts upon the city limits at the eastern boundary thereof; NOW THEREFORE, THE CITY OF JACKSON ORDAINS:

Section 1. The City Council hereby determines (a) that the annexation will be to the best interests of the City and of the territory affected; (b) that the territory described herein abuts upon the City limits and is, or is about to become, urban or suburban in character; and (c) that none of said territory is now included within the limits of any city, village or botough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the following described part of section 19, Township 102 North, Range 34, West of the Fifth Principal Meridian, Jackson County, Minnesota, and the same is hereby annexed to and included within the City as effectually as if it had already been a part thereof.

That part of the Northwest Quarter (NW 1/4) of Section Nineteen (19) in Township One Hundred Two (102) North, of Range Thirty-four west of the Fifth Principal Meridian; Beginning at a point 1709.0 feet South and 33 feet East of the Northwest corner of said Section 19-102-34W, thence East (internal angle 90°00') a distance of 622,29 feet, thence South and parallel with the West line of said Section 19, a distance of 350.0 feet, thence West a distance of 622.29 feet, thence North along the Easterly right-of-way and parallel with the West line of said Section 19, a distance of 350.0 feet to a point of beginning and containing 5.0 acres.

Section 3. Zoning District. The land hereby annexed to and included within the City is hereby designated as an Agriculture Residence District, "R-A".

Section 4. Filing. The City Administrator is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Jackson County Auditor, the Jackson County Recorder, and the Clerk of Wisconsin Township, Jackson County, Minnesota.

Section 5. Effective date. This ordinance takes effect fourteen (14) days after its publication.
