

ORDINANCE NO. 61

"AN ORDINANCE ANNEXING REAL PROPERTY"

The City Council of Taconite ordains:

Section 1. That the following described property is hereby annexed by the City of Taconite:

All that portion of the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$ of NW $\frac{1}{4}$) of said Section Twenty-seven (27), Township Fifty-six (56), North, Range Twenty-four (24) West of the Fourth Principal Meridian, according to the United States Government Survey thereof, described as follows:

Assuming that the North line of the Northwest Quarter of Northwest Quarter (NW $\frac{1}{4}$ of NW $\frac{1}{4}$) of said Section Twenty-seven (27) bears South 86 $^{\circ}$ - 17' - 30" West and beginning at a point on said North line 397.14 feet West of the Northeast corner of said Northwest Quarter of Northwest Quarter (NW $\frac{1}{4}$ of NW $\frac{1}{4}$) measured along said North line, go South 3 $^{\circ}$ - 46' East, a distance of 287.14 feet; thence South 86 $^{\circ}$ - 14' West, a distance of 238 feet; thence North 3 $^{\circ}$ 46' West, a distance of 287.14 feet to the North line of said Northwest Quarter of Northwest Quarter (NW $\frac{1}{4}$ of NW $\frac{1}{4}$); and thence North 86 $^{\circ}$ - 17' - 30" East along said North line, a distance of 238 feet to the point of beginning.


Section 2. The purpose of annexing the above-described property, owned by the City of Taconite, is to facilitate a sale of part or all of said property to the Itasca County Housing & Redevelopment Authority and for the convenience of the City of Taconite and the Itasca County Housing & Redevelopment Authority in providing housing for the elderly and family public housing.

Section 3. Effective Date.

This Ordinance becomes effective upon its approval by the Minnesota Municipal Board and filing with the proper agencies.

Passed by the Taconite City Council this 13th day of January, 1981.
