## CITY OF FARMINGTON DAKOTA COUNTY, MINNESOTA

## ORDINANCE NO. 081-113

An Ordinance declaring certain land in Empire Township annexed to the City of Farmington.

THE CITY COUNCIL OF THE CITY OF FARMINGTON ORDAINS AS FOLLOWS:

SECTION I

That all of the owners of all of the land hereinafter described have petitioned the City Council of the City of Farmington to have said land included within the City of Farmington.

SECTION II

That said land does not exceed 200 acres in area, is territory abutting on the City of Farmington, is not included in any other city or borough, is so conditioned as properly to be subjected to the government of the City of Farmington and is now or is about to become urban or suburban in character.



That it is hereby determined that the annexation of said land to the City of Farmington will be, and is, to the best interest of the City of Farmington and of the territory affected.

SECTION IV

That said ordinance shall be in full force and effect from and after its passage and publication, the filing of copies thereof with the Minnesota Municipal Board, the town clerk of the Township of Empire, the County Auditor of Dakota County, Minnesota, and the Secretary of State of the State of Minnesota, and its approval by the Minnesota Municipal Board.

SECTION V  $\cdot$ 

Title 1, Chapter 11, Section II(A) of the City Code is hereby amended by adding the following:

"14. Upon receipt of petition for annexation from Mr. and Mrs. O. T. Nordseth, et al, dated January 13, 1981, and upon receipt of approval and waiver from the Empire Townboard dated March 5, 1981, and upon adoption by the City Council of the City of Farmington of Ordinance No. 081-113, on the 11th day of March, 1981, shown under Minnesota Municipal Board Docket No. A-3795, that there is hereby annexed to the City of Farmington all the land lying and being in the County of Dakota and State of Minnesota, described as follows, to-wit:

The Southwest Quarter of the Southwest Quarter  $(SW_{\frac{1}{2}} \text{ of } SW_{\frac{1}{2}})$  of Section Thirty (30), Township One Hundred Fourteen (114), Range Nineteen (19);

the Southeast Quarter of the Southwest Quarter  $(SE_4^1 \text{ of } SW_4^1)$  of Section Thirty (30), Township One Hundred Fourteen (114), Range Nineteen (19); and that part of the Southwest Quarter of the Southeast Quarter  $(SW_4^1 \text{ of } SE_4^1)$  of Section Thirty (30), Town-ship One Hundred Fourteen (114), Range Nineteen (19), lying Westerly of the Right-of-Way of the Chicago, Milwaukee, St. Paul & Pacific Railroad; containing 94 acres, more or less, according to the Government Survey thereof together with all public roads and highways within or adjoining the premises aforesaid.
