AN ORDINANCE TO AMEND AN ORDINANCE KNOWN AS  
CHAPTER 13, UNCODED ORDINANCES IN EFFECT  
OF THE CITY CODE OF THE CITY OF MANKATO, MINNESOTA

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City, does not exceed 40 acres and is deemed to be or about to become urban or suburban in character;

THE CITY OF MANKATO, HEREBY ORDAINS THAT:

1. The annexation will be to the best interest of the City and of the land affected.
2. The land described herein is surrounded by the City and is or is about to become urban or suburban in character.
3. None of said land is now included within the limits of any city, village or borough.
4. The corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been part thereof:

Beginning at a point on the north line of Section Twenty (20), Township One Hundred Eight (108), Range Twenty-six (26), 625.95 feet west of the North Quarter (N 1/4) corner of said Section; thence north eighty-nine (89) degrees fifty-seven (57) minutes west of said north line, 695.70 feet to the northwest corner of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of said Section Twenty (20); thence south zero (0) degrees fourteen (14) minutes west on the west line of said Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) 459.36 feet; thence north eighty-two (82) degrees forty-one (41) minutes east 67.35 feet; thence north seventy (70) degrees forty-five (45) minutes east 44.95 feet; thence north fifty-nine (59) degrees twenty-three (23) minutes east 59.75 feet; thence north fifty-three (53) degrees east 672.36 feet to the point of beginning, containing 4.1 acres more or less.

The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the Blue Earth County Auditor and the Mankato Town Board.

This Ordinance shall take effect thirty (30) days after its passage by the Council of the City of Mankato, due publication thereof, and approval by the Minnesota Municipal Commission.

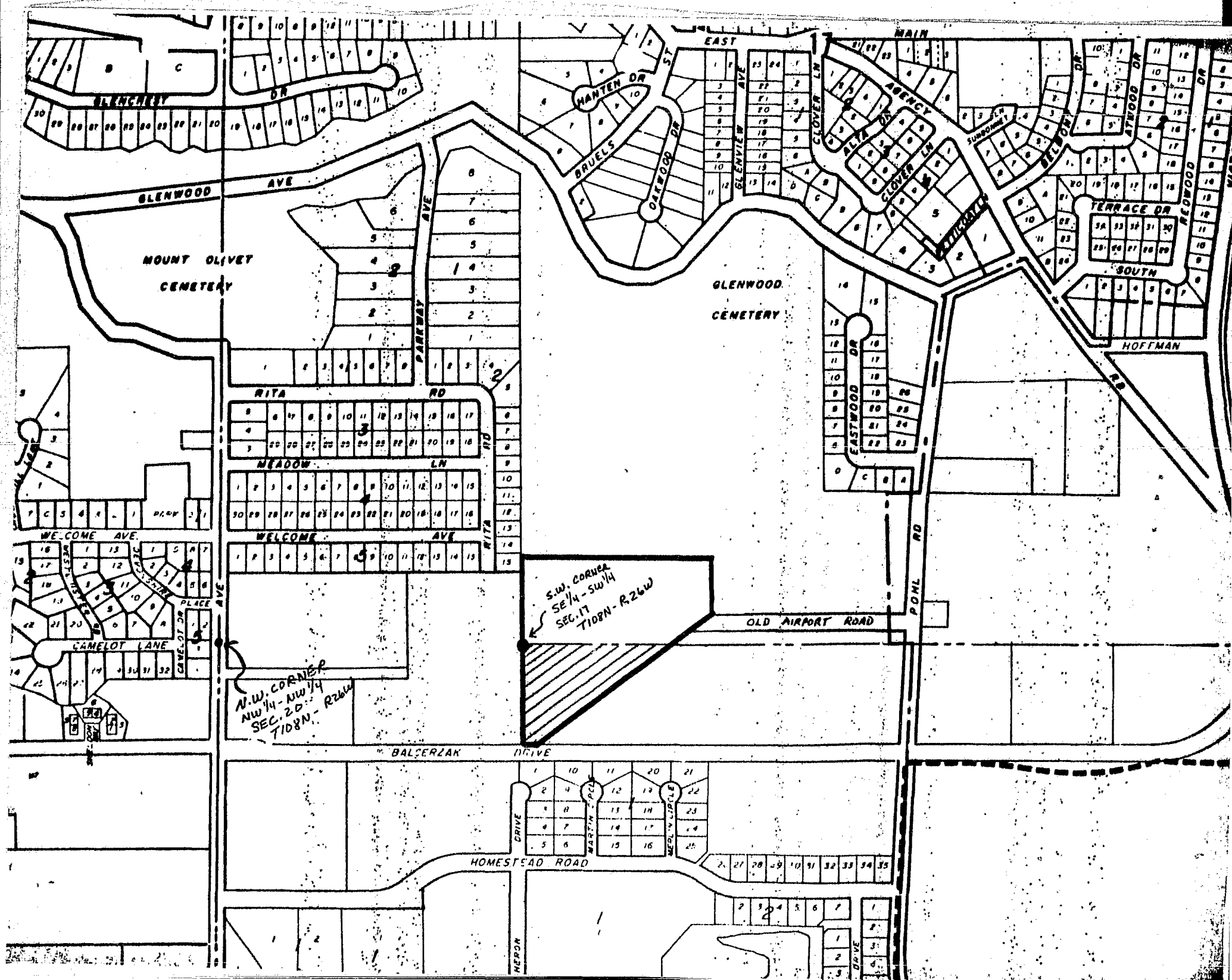
