On October 7, 1980, the Municipal Board issued an order annexing an area to the City of International Falls. The Board's decision included a property description which, through clerical error, was not recorded accurately in the final order. The amended description shall be substituted for the property description in FINDINGS OF FACT III on page 2 of the order and the property description in the ORDER I on page 5 of the October 7, 1980 order. The correct property description is as follows:

PROPERTY DESCRIPTION

AND

S $\frac{1}{2}$ -SW $\frac{1}{4}$ -SE $\frac{1}{4}$ and that part of the S $\frac{1}{2}$ -SE $\frac{1}{4}$ -SE $\frac{1}{4}$ lying west of the Minnesota Highway No. 332, Section 35, Township 71, Range 24.
