

ORDINANCE NO. 752

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WILLMAR, A MUNICIPAL CORPORATION OF THE STATE OF MINNESOTA, TO INCLUDE CERTAIN LANDS NOT EXCEEDING 200 ACRES.

WHEREAS, Petitions have been filed with the governing body of the City of Willmar, a municipal corporation in the State of Minnesota, by the sole owners having an interest therein, to have certain real property hereinafter described included within the limits of the City of Willmar, Minnesota; and

WHEREAS, it is proposed to annex by virtue hereof to the said City of Willmar, said property all of which said property is in Kandiyohi County, Minnesota; and

WHEREAS, pursuant to Minnesota law, said land may be annexed by ordinance; and

WHEREAS, the said real estate to be annexed consists of two (2) parcels, to-wit:

Parcel 1. Approximately 2.32 acres, more or less, described as follows, to-wit: The South 98 feet of the North 993 feet of the West 600 feet of the SW $\frac{1}{4}$  of the SW $\frac{1}{4}$ ; AND the South 100 feet of the North 1093 feet of the East 510 feet of the West 600 feet of the SW $\frac{1}{4}$  of the SW $\frac{1}{4}$ , both of Section 23, Township 119, Range 35.

Parcel 2. Approximately 3.40 acres, more or less, described as follows, to-wit: The East 510 feet of the West 600 feet of the SW $\frac{1}{4}$  of the SW $\frac{1}{4}$ , EXCEPT the North 1093 feet thereof, in Section 23, Township 119, Range 35, and the North 63.13 feet of the East 510 feet of the West 600 feet of the NW $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 26, all in Township 119, Range 35, Kandiyohi County, Minnesota.

NOW, THEREFORE, the City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. Best Interest of the City of Willmar and Area to be Annexed. That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected.

Section 2. Abuts on City Limits. That the real estate above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. Annexation. That the said real estate is hereby annexed to, and included within, the City of Willmar,

Minnesota, as effectually as if it had originally been a part hereof.

Section 4. Zoning. The parcels above described shall be zoned GB, General Business District.

Section 5. Effective Date. This Ordinance shall be filed and shall take effect and be in full force and effect from and after filing a certificate thereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota and the Secretary of State of the State of Minnesota, and from and after its passage and publication.

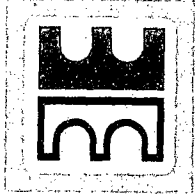
