FINDINGS OF FACT,
CONCLUSIONS OF LAW,
AND ORDER

On March 20, 1980 the Minnesota the Minnesota Municipal Board received resolutions from the City of Medicine Lake which requested the detachment of certain property and the City of Plymouth which requested the annexation of the same territory pursuant to Minnesota Statutes 414.061.

After review of the resolutions, the Minnesota Municipal Board hereby makes and files the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. That a resolution supporting detachment of certain properties was received from the City of Medicine Lake and a resolution supporting annexation of said property was received from the City of Plymouth.
2. The resolutions contained all the information required by statute including a description of the territory proposed for detachment which is as follows:

"Lots 13, 14, 15 and 16 Auditor's Subdivision Number 355, Hennepin County, Minnesota according to the recorded plat thereof. Together with easement for purposes of ingress and egress over the westerly 6 feet of Lot 2, and easterly 6 feet of Lot 3 and all of Lots 6, 18, 19, 11 and 12. Said Auditor's Subdivision No. 355, as shown in Deed Document No. 548853, Files of the Registrar of Titles"

3. The area proposed for detachment is situated within the City of Medicine Lake and abuts the municipal boundary of the City of Plymouth.

CONCLUSIONS OF LAW

1. The Minnesota Municipal Board duly acquired and now has jurisdiction of the within proceeding.
2. An order should be issued by the Minnesota Municipal Board concurrently detaching and annexing the area described herein.

Together with easement for purposes of ingress and egress over the westerly 6 feet of Lot 2, and easterly 6 feet of Lot 3 and all of Lots 6, 18, 19, 11 and 12. Said Auditor's Subdivision No. 355, as shown in Deed Document No. 548853, Files of the Registrar of Titles"
