ORDINANCE NO. 174  
2ND SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ALEXANDRIA TO  
INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING  
200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated February 9, 1981, requesting annexation of the territory hereinafter described was duly presented to the Council on the 9th day of February, 1981; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the City has received resolutions from the county and township waiving their objections to the annexation; and

WHEREAS, the land described in the petition abuts upon the city limits at the northwestern boundary thereof;

The Council of the City of Alexandria, Minnesota, ordains:

SECTION I. The City Council hereby determines (1) that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

SECTION II. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it has originally been a part thereof:

Lot Six (6), Block One (1), and Lot One (1), Block Two (2), KLOEHN'S SUBDIVISION, except that part of said Lot 1, Block 2, more particularly described as follows, to wit: To find the point of beginning commence at the Southerly most corner of Lot 1, said Block 2; thence on a record bearing N 47°00' W and along the Southwesterly line of Lot 1, said Block 2 a distance of 194.0 ft. to the point of beginning; thence from the point of beginning and leaving said Southwesterly line bearing N 43°00' E 160.0 ft; thence N 47°00' W 125.0 ft. to the intersection with the Northwesterly line of Lot 1, said Block 2; thence S 43°00' W and along said Northwesterly line 160.0 ft. to the Westerly most corner of Lot 1, said Block 2; thence S 47°00' E and along the Southwesterly line of Lot 1, said Block 2 a distance of 125.0 ft. to the point of beginning and containing 0.46 acres more or less.

SECTION III. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Alexandria Town Clerk and the County Auditor.

SECTION IV. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section III, and approval of the ordinance by the Minnesota Municipal Board.
