ORDINANCE NO. 142

*Dodge Center*

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF DODGE CENTER, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED TERRITORY OWNED BY THE CITY OF DODGE CENTER AND ABUTTING LAND WITHIN THE CITY LIMITS. (Dodge Center Airport)

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated City, or borough; and

WHEREAS, the City owns this territory which is abutted by lands already included within the corporate limits of the City and is deemed to be urban in character;

THE CITY COUNCIL OF DODGE CENTER, MINNESOTA ORDAINS:

Section 1. Territory Annexed. The corporate limits of the City of Dodge Center, Minnesota are hereby extended to include the unplatted territory owned by the City of Dodge Center, Minnesota described as follows:

Northwest Quarter (NW $\frac{1}{4}$ ) Section Two (2) Township One Hundred Six (106) North of Range Seventeen (17) West, and Beginning at a point on the North line of the Southwest Quarter (SW $\frac{1}{4}$ ) Section Two (2) Township One Hundred Six (106) North of Range Seventeen (17) which is 1714.72 feet Easterly on the Northwest corner of said Southwest Quarter (SW $\frac{1}{4}$ ) thence Easterly along said North line a distance of 917.48 feet to the NE corner of said SW $\frac{1}{4}$ , thence Southerly deflecting 89 $^{\circ}$ 52'00" along the East line of said SW $\frac{1}{4}$  a distance of 300.00 feet to a point, thence Westerly deflecting 90 $^{\circ}$ 08' and parallel to the North line of said SW $\frac{1}{4}$  a distance of 700.70 feet to a point, then deflect 54 $^{\circ}$ 04' a distance of 370.43 feet to the point of beginning, subject to easements of record.

Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Town Clerk of the affected Township and the Minnesota Municipal Board.

Section 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2 and approval of the same by the Minnesota Municipal Board.


