AN ORDINANCE PROVIDING FOR
THE ANNEXATION OF THE CHURCH
OF JESUS CHRIST OF LATTER-DAY
SAINTS' PROPERTY TO THE CITY OF BRAINERD

ORDINANCE NO. 764

The Council of the City of Brainerd does ordain:

SECTION 1. That the corporation of the presiding Bishop of the Church of Jesus Christ of Latter-Day Saints', a Utah corporation, the fee owner of:

That part of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$), Section Two (2), Township Forty-four North (44N), Range Thirty-one West (31W), Crow Wing County, Minnesota, described as follows: Beginning at the north-east corner of said Section 2, (as monumented by a 2 inch iron pipe) thence South 87°20' West (assuming the east line of the NE $\frac{1}{4}$ of said Section 2 has a bearing of South) along the North line of said Section 2 a distance of 361.78 feet; thence South 0°00' West a distance of 371.78 feet; thence North 87°20' East a distance of 361.78 feet to a point on the east line of said Section 2; thence North 0°00' East along the east line of said Section 2 a distance of 371.78 feet to the point of beginning.

filed a petition with the Council of the City of Brainerd on July 7, 1980 requesting that said realty be annexed to the City of Brainerd.


SECTION 2. That pursuant to Minnesota Statutes 414.033, more than ninety (90) days have elapsed since the filing of said petition and no objections have been filed or received by the Council of the City of Brainerd.

SECTION 3. That Council of the City of Brainerd deems the annexation of said realty to the City of Brainerd to be in the best interests of the City of Brainerd and the territory affected and, accordingly, said realty is hereby annexed to the City of Brainerd so as to become and be a part of the City of Brainerd and included within its corporate limits and boundaries thereof.


SECTION 4. This ordinance shall take effect and be in force one week from and after its publication.


