ORDINANCE NO. 106

An ordinance annexing certain territory and extending the corporate limits of the City of Sherburn, Martin County, Minnesota.

Be it ordained by the City Council, City of Sherburn, Minnesota, as follows:

Section 1. That the property hereinafter described abuts upon the corporate limits of the City of Sherburn, Minnesota and that the quantity of land and boundaries of land to be annexed constitute less than 200 acres and all of the property owners of said land have petitioned the City Council of the City of Sherburn, Minnesota, to have such land included within the municipality of the City of Sherburn, Minnesota; That Notice of the Petition of Mathias J. Theobald as attorney in fact for Barbara Theobald and as co-personal representative of the estate of Anna Mauris and by Robert Mauris also co-personal representative of the estate of Anna Mauris to the City of Sherburn, was served upon the Manyaska Township Board on the 20th day of Nov., 1980, a copy of said Petition was served upon Robert Katzenberger, Martin County Auditor on behalf of the County Commissioners of Martin County, Minnesota, this 20th day of November, 1980, a copy of said Petition was served upon the City Council for the City of Sherburn, on the 20th day of Nov., 1980 and that a copy of said Petition was filed with the State of Minnesota Municipal Board on the 20th day of Nov., 1980; That it will be in the best interests of the municipality and the territory effected

to annex said territory; That said property is urban in character and subject to annexation pursuant to Minnesota Statutes 414.033, Subdivision 5.

Section 2. That said property is located in the County of Martin, State of Minnesota, described as follows, to-wit:

A tract of land in the Northwest quarter of the Northeast Quarter of Section 18, Township 102 North, Range 32 West in Martin County, Minnesota described as follows:

Commencing at the Northwest corner of the Northeast Quarter of Section 18, Township 102 North, Range 32 West in Martin County, Minnesota; thence North 90 degrees 00 minutes 00 seconds East (assumed bearing) along the North line of the Northeast Quarter a distance of 561.00 feet to the point of beginning and northeast corner of a tract deeded to Albin J. and Donna J. Nawrocki and recorded and described in the office of the Martin County Recorder in Book 318 of Deeds, page 356; thence continuing North 90 degrees 00 minutes 00 seconds East along the North line of the Northeast Quarter a distance of 356.00 feet; thence South 0 degrees 18 minutes 35 seconds East parallel with West line of the Northeast Quarter a distance of 563.90 feet; thence South 90 degrees 00 minutes 00 seconds West parallel with the North line of the Northeast Quarter a distance of 356.00 feet to the east line of said Nawrocki tract; thence North 0 degrees 18 minutes 35 seconds West along the east line of said Nawrocki tract a distance of 563.90 feet to the point of beginning. Subject to an easement for public roadway right-of-way along the North line of the Northeast Quarter of Section 18.

Said tract contains 4.609 acres including the aforementioned easement.


Section 3. That the above described property is hereby made a part of the City of Sherburn, Minnesota and that the maps of the City of Sherburn shall be and they hereby are amended to include all of the above described property as part

of the City of Sherburn, Minnesota.

Section 4. That this ordinance shall be in force and effect from and after it's passage and publication, and the filing of certified copies with the State of Minnesota Municipal Board, Martin County Auditor, The Secretary of State, The County Recorder for Martin County, Minnesota, and the Town Clerk for the Township of Manyaska, Martin County, Minnesota.




Dear Mrs. Growe:
