AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE SECRETARY OF State CHISAGO CITY TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the city and is deemed to be urban or suburban in character;

The City Council of Chisago City ordains:

4.1

Section 1. Territory annexed. The corporate limits of the city of Chisago City, Minnesota, are hereby extended to include the platted territory described as follows, 60% or more of the perimeter of which territory is bordered by territory already included within the city limits:

> Lots 1, 2, 3, 4, 15 & 16 of Block 43; Lots 10 - 23, inclusive, of Block 50; Lots 1 - 8, inclusive, of Block 59; and All of Blocks 57, 64, 65, 66, 75, 76 & 77, All in Chisago City Plat.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

Section 3. Effective date of annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2 and approval by the Minnesota Municipal Board.
