ORDINANCE NO. 1980-4

STATE OF MINNESOTA

AN ORDINANCE EXTENDING THE CORPORATE LIMITS

OF THE CITY OF ALBERTVILLE, MINNESOTA
TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED
LAND NOT EXCEEDING 40 ACRES IN AREA ABUTTING LIMITS

UPON THE CITY LIMITS OF ALBERTVILLE

WHEREAS, a certain Notice of Intent to Annex, dated August 3, 1980, the lands hereinafter described, was duly served on the Municipal Board; and

WHEREAS, more than 90 days have expired and no objection has been filed pursuant to Minnesota Statutes, Section 414.033, Subd. 3;

The Council of the City of Albertville, Minnesota ordains:

Section 1. The City Council hereby determines: (1) that

the territory described herein abuts upon the city limits and

is urban or suburban in character; (2) that none of the territory

is now included within the limits of any city; and (3) that the

area to be annexed is more than 60% bordered by the City of Albertvil

Section 2. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof;

PARCELS 4, 5 and 6

A tract of land in Lot "G" of the W1/2 of SE1/4 according to the plat of said Lot G made August 29, 1913 by M.T. Moland and recorded in Book 2 of Plats, page 91, and also in SE1/4, all in Section 1, Township 120, Range 24, described as follows: Commencing at the SW corner of SE1/4 of Section 1, Township 120, Range 24, thence East on the South line of said SE1/4 479.76 feet to the point of beginning; thence continuing on the same line 402.72 feet; thence North 2°00'08" East, 773.00 feet; thence North 87°34'29" West, 402.72 feet; thence South along the West line of the East 1/2 of the SE1/4, Section 1, Township 120, Range 24 to the point of beginning.

Section 3. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Frankfort Town Clerk, and the Wright County Auditor.

Section 4. This Ordinance takes effect upon its passage

and publication and the filing of certified copies as directed in Section 3, and approved of the Ordinance by the Minnesota Municipal Board.
