ORDINANCE NO. 107

ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ISANTI TO INCLUDE CERTAIN UNINCORPORATED TERRITORY, 60 PERCENT OR MORE OF THE PERIMETER OF WHICH IS BORDERED BY LAND WITHIN THE CITY LIMITS OF THE CITY OF ISANTI

WHEREAS, certain territory described below is not presently located within the corporate limits of any incorporated city; and WHEREAS, 60 percent or more of the perimeter of this territory is bordered by lands already included within the corporate

limits of the City and is deemed to be urban or suburban in character;

NOW, THEREFORE, THE CITY OF ISANTI DOES ORDAIN:

Section 1. <u>Territory Annexed</u>. The corporate limits of the City of Isanti, Minnesota, are hereby extended to include the unplatted territory described as follows, 60 percent or more of the perimeter of which territory is bordered by territory already included within the city limits:

PARCEL A:

That part of the Southeast Quarter of Southwest Quarter (SE 1/4 of SW 1/4) of Section Twenty-nine (29), Township Thirty-five (35), Range Twenty-three (23), described by metes and bounds as follows: Beginning at the Southwest corner of Norman's Acres, according to the plat thereof on file and of record in the office of the Register of Deeds in and for the County of Isanti, State of Minnesota; thence South on the West line of said Southeast Quarter of Southwest Quarter (SE 1/4 of SW 1/4), 137.5 feet; thence East parallel to the South line of said Norman's Acres, 165 feet; thence North parallel to the West line of said SE 1/4 of SW 1/4, 137.5 feet and to the South line of said Norman's Acres; thence West on the South line of said Norman's Acres to the point of beginning and there to terminate.

PARCEL B:

That certain part of the SE 1/4 of SW 1/4 of Section 29, Township 35, Range 23, and in the Village of Isanti, described as follows, towit:

Beginning at a point on the West line of said tract 273.5 feet south of the Southwest corner of Norman's acres as per recorded plat thereof; thence continuing South on same line, for 273.5 feet to the North line of a public road; thence East along said road line for 75 feet; thence North, parallel to described first course, for 273.5 feet; thence West for 75 feet to the point of beginning. Any right of title existing in said adjacent public road included, to the centerline thereof. Also the following described parcel in the SE 1/4 of SW 1/4, Sec. 29, Twp. 35, Range 23: Beginning at a point on the West line of said tract 273.5 feet south of the Southwest corner of Norman's Acres; thence north on the West line of said tract 136 feet; thence east parallel to the South line of said Norman's Acres, 75 feet; thence South parallel to the West line of said SE 1/4 of SW 1/4 136 feet and to the Northeast corner of a tract of land conveyed by parties of the first part herein by a Warranty Deed dated Nov. 19, 1963, and recorded in Book "57" of Deeds, page 300; thence West on the North line thereof to the point of beginning and there to terminate, according to the plat thereof on file and of record in the office of the Register of Deeds in and for Isanti County, Minnesota.

Section 2. <u>Filing</u>. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the Isanti County Auditor, the Isanti Township Clerk, and the Minnesota Municipal Board.

Section 3. <u>Effective Date of Annexation</u>. This annexation shall be complete at such time as this ordinance becomes effective,

30 days from the date of its publication in the official newspaper, after the filing of certified copies as directed in Section 2 and approval by the Minnesota Municipal Board.
