
Re: City of Palisade Annexation Ordinance No. 33

ORDINANCE NO. 33

AN ORDINANCE ANNEXING UNPLATTED  
LAND TO THE CITY OF PALISADE

WHEREAS, the City of Palisade, a political subdivision of the County of Aitkin, State of Minnesota, is the absolute owner in fee of the real property in Aitkin County, Minnesota, described as follows:

That part of the Northeast Quarter of Southwest Quarter (NE $\frac{1}{4}$  of SW $\frac{1}{4}$ ) lying Southwesterly of the right-of-way of the Minneapolis, St. Paul and Sault Ste. Marie Railway Company, in Section Twenty-two (22), Township Forty-nine (49), Range Twenty-five (25); and

WHEREAS, this unincorporated property is unplatted and is abutting the existing corporate limits of the City of Palisade; and

WHEREAS, said land is deemed to be urban or suburban in character; and

WHEREAS, M.S.A. 414.033, Subd. 1 and Subd. 2 (a) authorizes and permits the annexation of such land to the municipality by ordinance.

THE COUNCIL OF THE CITY OF PALISADE, MINNESOTA ORDAINS:


Section 1. Territory Annexed. The corporate limits of the City of Palisade, in the County of Aitkin, State of Minnesota, are hereby extended to include that tract of unplatted land described as follows and the same is hereby annexed to and included within the City of Palisade as effectually as if it had originally been a part thereof:

That part of the Northeast Quarter of Southwest Quarter (NE $\frac{1}{4}$  of SW $\frac{1}{4}$ ) lying Southwesterly of the right-of-way of the Minneapolis, St. Paul and Sault Ste. Marie Railway Company, in Section Twenty-two (22), Township Forty-nine (49), Range Twenty-five (25).


Section 2. Filing. The City Clerk is hereby directed to file a copy of this annexation ordinance with the Minnesota Municipal Board, the Clerk of the Township of Logan, the Aitkin County Auditor and the Minnesota Secretary of State.


Section 3. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the copies thereof as aforesaid.
