ORDINANCE NO. 111

An Ordinance extending the corporate limits of the City of Goodhue to include certain unincorporated unplatted land not exceeding 200 acres abutting upon the city limits.

WHEREAS, a petition requesting annexation of the territory hereinafter described was duly presented to the council on the 11th day of June, 1980; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits of the City of Goodhue at the westerly boundary thereof, and northerly of Gadiant-Schulz Addition to the City of Goodhue, and none of it is presently within the corporate limits of any incorporated city,

The council of the City of Goodhue, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

Section 2. Territory annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Part of the East Half ( $E\frac{1}{2}$ ) of the Southeast Quarter ( $SE\frac{1}{4}$ ) of Section 20, in Township 111 North, Range 15 West, in the County of Goodhue, State of Minnesota, described as follows: Beginning at a point 49.16 rods North of the southeast corner of said Section 20, running thence West 52.35 rods, thence North 45.84 rods, thence East 52.35 rods, thence South 45.84 rods to place of beginning.

Except that part of the East 300.00 feet thereof which lies South of a line 160.00 feet North of, as measured at a right angle to and parallel with the north line of Third Avenue, as now located and established.





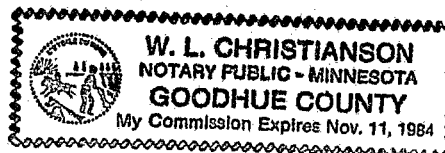
