AN ORDINANCE TO AMEND AN ORDINANCE KNOWN  
AS CHAPTER 13, UNCODED ORDINANCES IN EFFECT  
OF THE CITY CODE OF THE CITY OF MANKATO, MINNESOTA

WHEREAS, certain property described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this property abuts the corporate limits of the City of Mankato, is owned by the City of Mankato, is used as a city recreational park, does not exceed 40 acres and is deemed to be urban or suburban in character; and

WHEREAS, no objections to the annexation have been received from the Mankato Town Board or Blue Earth County Board of Commissioners:

THE CITY OF MANKATO, HEREBY ORDAINS THAT:

1. That the annexation will be in the best interests of the City and of the land affected.
2. That the City will be able to provide municipal services to a City owned property being used for urban recreational purposes.
3. That said land is not now included within the limits of any city, village or borough.

The corporate limits of the city are hereby extended to include the land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been part thereof:

All that part of the Northwest Quarter of the Southeast Quarter of Section 16, Township 108 North, Range 26 West described as follows: Commencing at the Center of said Section 16; thence North  $90^{\circ}-00'$  East on an assumed bearing along the North line of said Northwest Quarter of the Southeast Quarter 440.00 feet to the Southeast Corner of Lot 3, Block 3 of Kenwood Heights Addition to the City of Mankato, Minnesota, the place of beginning; thence continuing along the last described courses, 535.00 feet; thence South  $0^{\circ}-17.7'$  East and parallel to the West line of said Northwest Quarter of the Southeast Quarter 1,314.95 feet to the South line of said Northwest Quarter of the Southeast Quarter; thence North  $89^{\circ}-48'$  West along the South line of said Northwest Quarter of the Southeast Quarter 541.75 feet; thence North  $0^{\circ}-00'$ , 1,313.05 feet to the place of beginning. Said tract contains 16.2 acres of land more or less, and is subject to a roadway easement across the Southerly boundary thereof.

The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the Blue Earth County Auditor and the Mankato Town Board. This Ordinance shall take effect

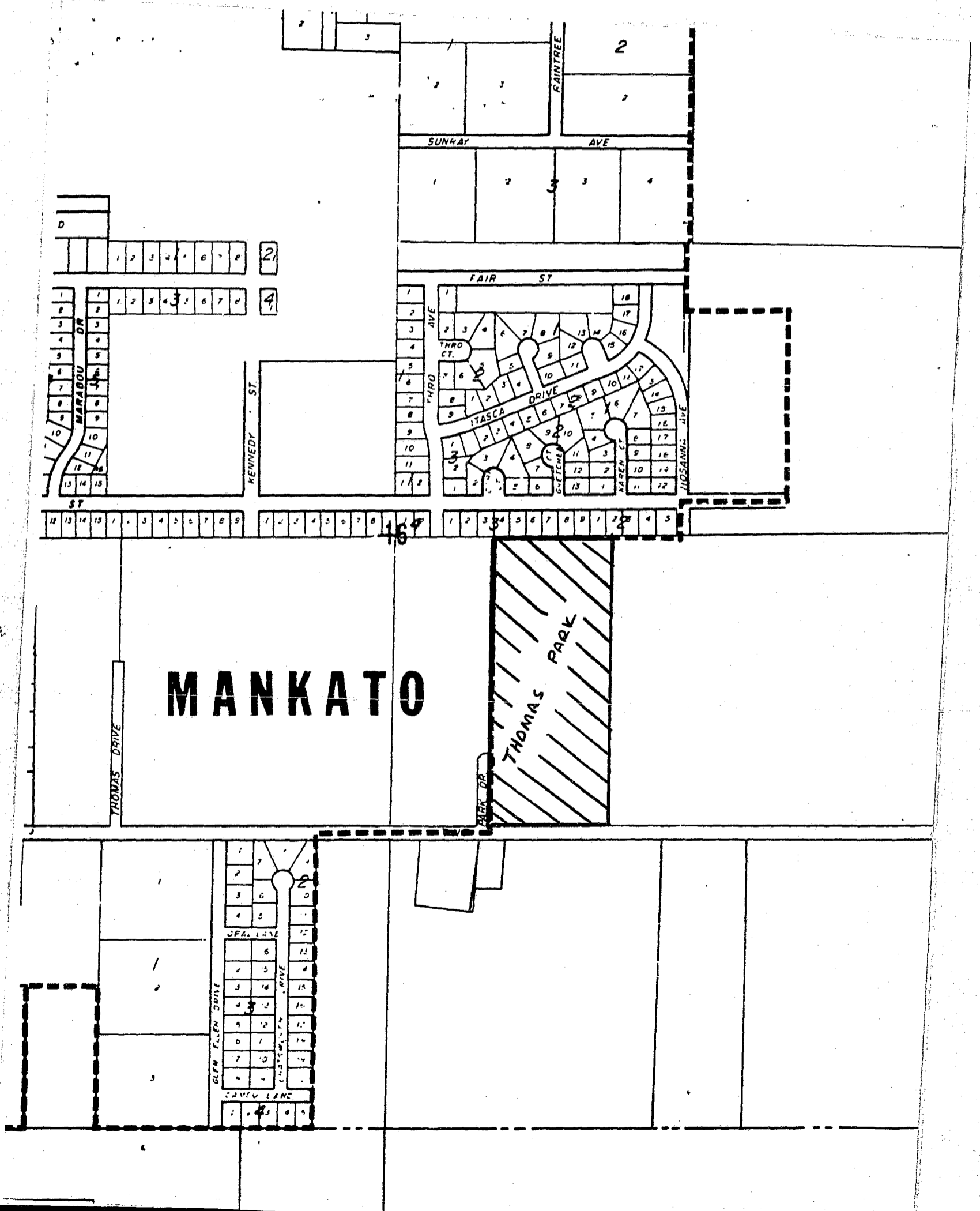

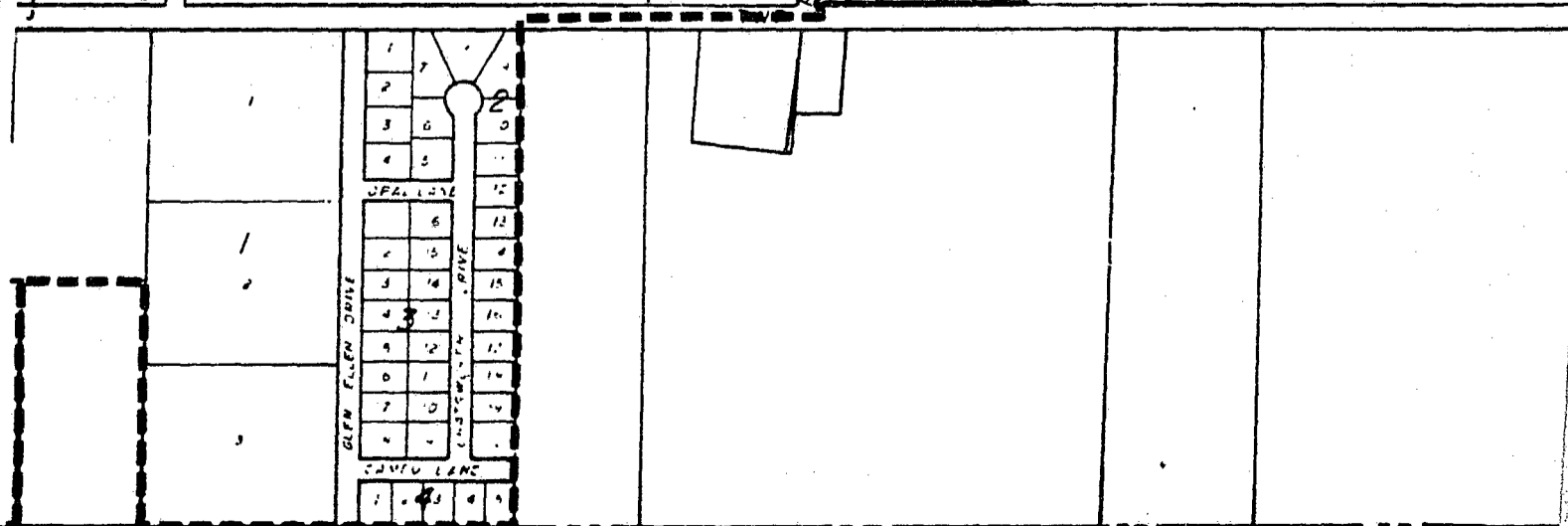
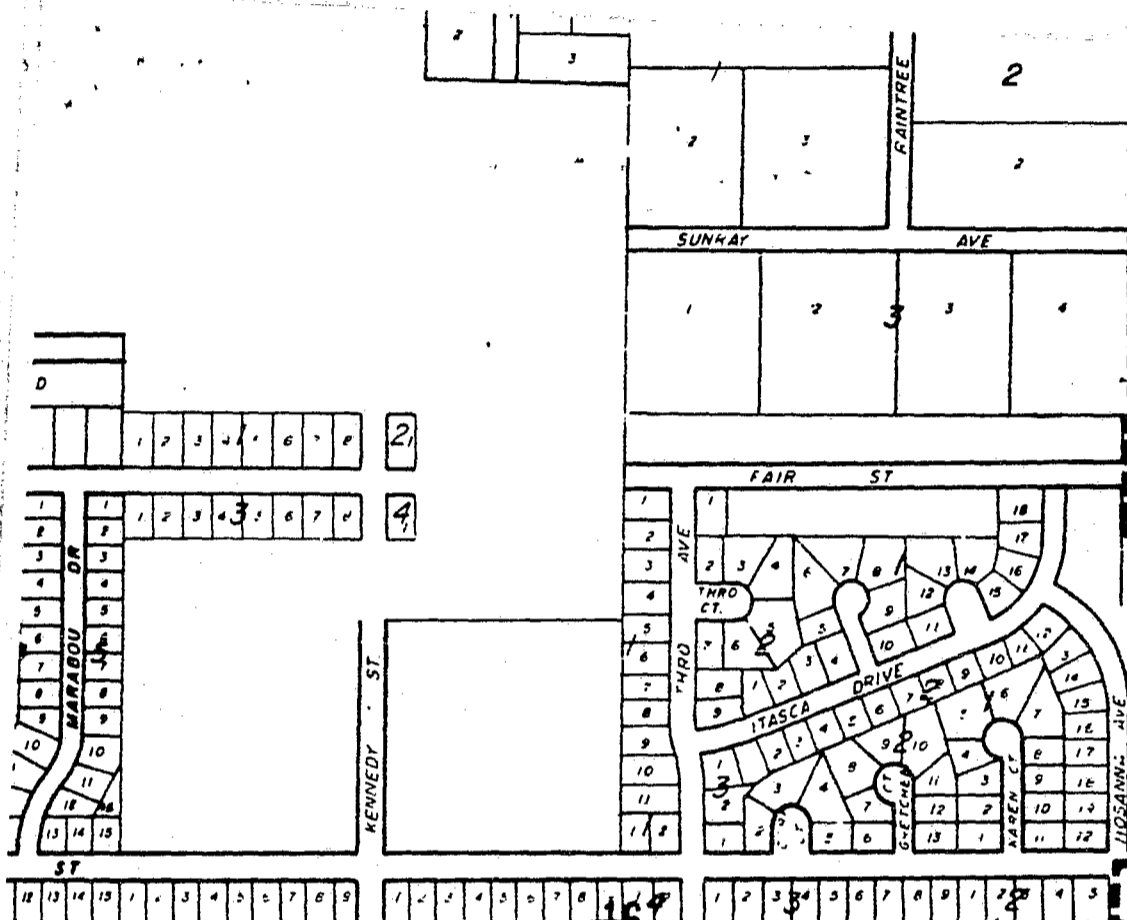
