CHAPTER NO. 431

AN ORDINANCE ANNEXING CERTAIN LANDS

TO THE CITY OF SAUK CENTRE

THE CITY OF SAUK CENTRE DOES ORDAIN:

Section 1. That the following described real property, is completely surrounded by land within the municipal limits of the City of Sauk Centre, to-wit:

That part of State Road which lies North of the railroad right of way and lying East of the North-South quarter line of Section 15, Township 126, Range 24.

Section 2. That it will be in the best interest of the said City of Sauk Centre that the said lands be annexed to the said City, and said lands are hereby annexed, taken into, and are hereby made a part of the said City of Sauk Centre in Stearns County, Minnesota.

Section 3. That this Ordinance will take effect and be in force thirty (30) days after its publication.


