ORDINANCE NO. 18. SECOND SERIES

EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY OWNED BY THE CITY OF AUSTIN AND ABUTTING THEREON.

WHEREAS, the territory described below is not presently included within the corporate limits of any city, village or borough;

WHEREAS, the City of Austin is the owner of the land described below and said premises adjoin the City of Austin and are deemed to be urban in character;

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

Section 1:

Tract 1: Beginning at the northwest corner of Lot 1, Block 8, of Sun Valley First Addition to the City of Austin, Mower County, Minnesota, thence north-westerly along the west line of Lot A of South Streverling Addition to a point that intersects the northerly line about Lot A of Crestwood Hills 2nd Addition extended easterly thence southwesterly along the north line of said Outlot A to the Northeast corner of Lot 17, Crestwood Hills 2nd Addition thence southwesterly along the north line of Lot 17 to the northwest corner of said lot thence southwesterly on the extention of. the north line of said Lot 17 to the center line of 23rd Street S.W. thence southerly along the centerline of 23rd Street S.W. to a point that intersects the south line Lot 18 Crestwood Hills Second Addition extended westerly thence easterly along the south line of said Lot 18 to the southeast corner of said Lot 18. This point also being on the westerly line of Outlot A in Crestwood Hills Second Addition thence continuing easterly on the extension of the south line of said Lot 18 to the easterly line of said Outlot A thence northwesterly along the easterly line of said Outlot A to the intersection of said line with the westerly extension of the northerly line of Lot 1 of Block 8 of Sun Valley First Addition thence easterly 67 feet along the extended northerly line of said Lot 1 to the point of beginning.

Tract 2.

Outlots in the J.P. Nielsen Plat of Outlots - Included are:

North $\frac{1}{2}$ of Outlot 18 and Outlots 26, 27, 28, 29, 30, 37, 38, 39, 52 and 53 in the southeast $\frac{1}{4}$ Section 26 and the southwest $\frac{1}{4}$ section 25, Township 103 North, Range 18 West, Mower County, Minnesota.

Section II: The City Recorder is directed to file certified copies of said ordinance with the Minnesota Municipal Commission, Austin Township Clerk, Lansing Township Clerk, County Auditor, County Recorder, Austin Utilities and the Secretary of State.

Section III: The ordinance takes effect upon its passage and publication, filing certified copies as directed in Section 2.
