AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF DILWORTH, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council on the $\underline{11}$ day of $\underline{11}$, $\underline{1981}$; and

WHEREAS the quantity of land embraced within the area described in the petition and bounded as described is 33,47acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS the petition was signed by the sole owner, Burlington Northern, Inc.; and

WHEREAS no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS the land described in the petition abuts upon the city limits at the Easterly boundary thereof; the Council of the City of Dilworth, Minnesota, ordains:

SECTION 1. The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is or is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

SECTION 2. TERRITORY ANNEXED. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Those portions of Burlington Northern Inc. main line right of way and adjacent property in the N½NW¼ and in the NW½NE¼ of Section 7, Township 139 North, Range 47 West, Fifth Principal Meridian, being more particularly described as follows:

Beginning at a point on the west line of said Section 7 distant 381 feet southerly, measured along said west line, from the northwest corner of said Section 7 and distant 519 feet northerly, measured along said west line of said Section 7, from the center line of Burlington Northern Inc. westbound main track as hereinafter described; thence north 89 degrees, 37 minutes east to a point on the east line of the NW{NW} (Gov. Lot 1) of said Section 7 distant 519 feet northerly, measured along said east line of said NW4NW4 (Gov. Lot 1), from said main track center line; thence southeasterly on a straight line across the NE4NW4 of said Section 7 to a point on the east line of said NE4NW4 of said Section 7 distant 249 feet northerly, measured along said east line of said NE%NW% of said Section 7, from said main track center line; thence North 89 degrees, 37 minutes east to a point in a line at right, angles to said main track center line, at a point therein distant 2215.2 feet westerly, measured along said main track center line, from the east line of said Section 7; thence southerly at right angles to said main track center line a distance of 350 feet to a point distant 101 feet southerly, measured at right angles, from said main track center line; thence south 89 degrees, 37 minutes west, parallel with said main track center line to a point on said west line of said Section 7 distant 101 feet southerly, measured along said
