

IN THE MATTER OF THE APPLICATION BY
THE HONORABLE GLEN W. SWENSON, JUDGE
OF COUNTY COURT OF THE COUNTY OF WRIGHT,
STATE OF MINNESOTA, FOR AN EXTENSION OF
HIS TERM OF OFFICE PURSUANT TO THE
PROVISIONS OF MINNESOTA STATUTES
SECTION 490.124

WHEREAS, the Honorable Glen W. Swenson, Judge of the
County Court in and for the County of Wright, State of
Minnesota, attained the age of seventy years on April 8, 1980,
thus establishing a "mandatory retirement date" of April 30, 1980,
in accordance with the provisions of Minnesota Statutes Section
490.121, Subdivision 12; and

WHEREAS, the said Glen W. Swenson was elected County Court
Judge in and for the County of Wright in November, 1972; took
office on January 1, 1973; and was re-elected in November, 1978
for a term beginning January 1, 1979 and ending December 31, 1984;
and


WHEREAS, the said Glen W. Swenson has submitted his
written application to the undersigned Governor Albert H. Quie,
by letter dated March 27, 1980, requesting that he be granted
an extension of his term of office beyond his "mandatory
retirement date" in accordance with the provisions of Minnesota
Statutes Section 490.124, Subdivision 2; and

WHEREAS, Minnesota Statutes Section 490.124, Subdivision
2 requires the Governor to make a written Order accepting such
retirement application and extending such term of office.


NOW, THEREFORE, I, Albert H. Quie, Governor of the State
of Minnesota, acting in accordance with Minnesota Statutes,
Section 490.124, Subdivision 2, and pursuant to the provisions
of a judgment entered by the Clerk of District Court for the
Tenth Judicial District on September 8, 1981 pursuant to an
order for judgment issued by the Honorable John A. Spellacy,
Judge of District Court, on August 31, 1981, do hereby order that
the mandatory retirement date for said Glen W. Swenson be, and it
hereby is, extended to December 31, 1982. He shall become entitled
thereafter to such retirement compensation as is provided under
the provisions of Minnesota Statutes Chapter 490.


I hereby direct that this Order be filed in the Office
