ORDINANCE NO. 225

ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF  
CHATFIELD, MINNESOTA

The council of the City of Chatfield, Minnesota does ordain:

1. That the following described lands, situated in the southeast Quarter of the Southwest Quarter all in Section 4, Township 104 North Range 11 West, Fillmore County, Minnesota are hereby annexed to the City of Chatfield, Minnesota, to-wit:

Commencing 495.00 feet West (Assumed bearing) on the section line from the southeast corner of the southeast Quarter of the southwest Quarter, Section 4, Township 104 North, Range 11 West, County of Fillmore, State of Minnesota, at the BEGINNING CORNER; proceed west on said Section Line a distance of 550.00 feet, thence North a distance of 473.00 feet; thence East on a line parallel to said section line, a distance of 550.00 feet; thence South to the POINT OF BEGINNING, a distance of 473.00 feet; The enclosure containing 5.97 acres, more or less, being subject to existing easements and rights-of-way.

That, upon approval of this ordinance by the Minnesota Municipal Board, all plats inconsistent with this Ordinance shall be altered and modified to the extent of such inconsistency, but no farther.


