ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MOORHEAD TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES IN AREA ABUTTING UPON THE CITY LIMITS AT THE NORTHEASTERLY BOUNDARY THEREOF.

WHEREAS, a certain Petition requesting annexation of the land hereinafter described was duly presented to the Council; and

WHEREAS, the quantity of land embraced within the area in the Petition and bounded as described is less than 200 acres of unplatted land no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the Petition was signed by all of the owners of the real estate involved; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the city limits at the northeasterly boundary of said city;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Moorhead, as follows:

Section 1. The City Council does hereby determine (1) that the annexation will be to the best interest of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. TERRITORY ANNEXED. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof, said land being described as follows:

All that part of the Southeast Quarter (SE%) of Section Thirty-Three (33), Township One Hundred Forty (140), Range Forty-Eight (48), lying East of the East right-of-way line of Trunk Highway #75 as said right-of-way is established as of this date, excepting, however, the following described two tracts:

- 1. The Southwest Quarter (SW4) of the Southeast Quarter (SE4) of said Section Thirty-three (33), Township One hundred Forty (140), Range Forty-Eight (48), which has heretofore been conveyed to the City of Moorhead.
- 2. A tract beginning at a point on the East line of said right-of-way line of Trunk Highway #75 located 1316.94 feet North of the South line of said Section Thirty-Three

(33); thence North along the East right-of-way line of Trunk Highway #75 a distance of 581 feet; thence in an Easterly direction 1125.33 feet; thence South and parallel to the East right-of-way line of Trunk Highway #75 a distance of 581 feet; thence Westerly a distance of 1125.33 feet to the point of beginning, said tract having been heretofore conveyed to the City of Moorhead, Said tract herewith annexed containing 106 acres more or less.

Section 3. FILING. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section 4. EFFECTIVE DATE. This ordinance takes effect upon its passage and publication and the filing of the ceritified copies as directed in Section 3.
