

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ALEXANDRIA, MINNESOTA TO INCLUDE "OAK KNOLL FIRST ADDITION"

WHEREAS, a certain petition dated September 4, 1981 and received by the City of Alexandria, Minnesota on September 8, 1981, requesting annexation of the territory hereinafter described was duly presented to the City Council on the 14th day of September, 1981; and

WHEREAS, the petition was signed by nine (9) property owners, constituting a majority but not all of a total number of fifteen (15) property owners; and

WHEREAS, notice of such petition was sent to and received by Alexandria Township, Douglas County Board of Commissioners and the Minnesota Municipal Board within ten (10) days of the City receiving the petition; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed, and

WHEREAS, the land to be annexed is unincorporated platted land abutting upon the City Limits at the northeastern boundary thereof; and

WHEREAS, a hearing was duly held by the City Council of the City of Alexandria, Minnesota on the proposed annexation on December 14, 1981 after at least 30 days mailed notice;

THEREFORE, The City Council of the City of Alexandria, Minnesota ORDAINS:

SECTION I. General. The City Council hereby determines (1) that the territory described herein abuts upon the City Limits and is urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

SECTION II. Territory Annexed. The Corporate Limits of the City of Alexandria, Minnesota are hereby extended to include the platted land legally described as follows:

Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 & 13, Block 1, "Oak Knoll First Addition"

Lots 1, 2, 3, 4, & 5, Block 2, "Oak Knoll First Addition"

Lots 1, 2, & 3, Block 3, "Oak Knoll First Addition"

and the same is hereby annexed to and included within the City effectually as if it had originally been a part thereof.

SECTION III. Filing. The City Administrator is hereby directed file certified copies of this ordinance with the Minnesota Municipal Board, the Minnesota Secretary of State, the Alexandria Town Clerk and the Douglas County Auditor.

SECTION IV. Effective Date. This annexation shall become effective as of January 1, 1982.
