AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF RAYMOND, A MUNICIPAL CORPORATION OF THE STATE OF MINNESOTA, TO INCLUDE CERTAIN LANDS NOT EXCEEDING 200 ACRES.

WHEREAS, a petition has been filed with the governing body of the City of Raymond, a municipal corporation of the State of Minnesota, by the sole owners having an interest therein, to have certain real property hereinafter described included within the limits of the City of Raymond, Minnesota, and

WHEREAS, it is proposed to annex by virtue hereof to the said City of Raymond, said property, all of which said property is in Kandiyohi County, State of Minnesota, and

WHEREAS, the said property to be annexed consists of approximately 14.3 acres, more or less, described as follows, to-wit:

All that part of the Southeast Quarter (SE 1/4) of Section Nineteen (19), Township One Hundred Eighteen (118) North, Range Thirty-six (36) West of the 5th Principal Meridian in Kandiyohi County described as follows, to-wit:

Beginning on the East line of said Section Nineteen (19) a distance of 417.40 feet bearing South of the Northeast corner of the Southeast Quarter (SE 1/4) of said Section Nineteen (19); thence S 87°50' W parallel the North line of the Southeast Quarter (SE 1/4) of said Section Nineteen (19) for 563.00 feet; thence South parallel the East line of said Section Nineteen (19) for 1190.00 feet; thence N 87°50' E for 563.00 feet to the East line of said Section Nineteen (19); thence North 1190.00 feet to the point of beginning; ALSO

All that part of the Southeast Quarter (SE 1/4) of Section Nineteen (19), Township One Hundred Eighteen (118) North, Range Thirty-six (36) West of the 5th Principal Meridian in Kandiyohi County described as follows, to-wit:

Beginning on the East line of said Section Nineteen (19) a distance of 417.40 feet bearing South of the Northeast corner of the Southeast Quarter (SE 1/4) of said Section Nineteen (19), thence S 87°50' W parallel the North line of the Southeast Quarter (SE 1/4) of said Section Nineteen (19) for 563.00 feet to the point of beginning; thence continuing S 87°50' W parallel the North line of the Southeast Quarter (SE 1/4) of said Section Nineteen (19) for 475.00 feet; thence South parallel the east line of said Section Nineteen (19) for 60.00 feet; thence N 87°50' E for 475.00 feet; thence North 60.00 feet to the point of beginning.

NOW, THEREFORE, the City Council of the City of Raymond hereby determines, ordains and declares as follows:

SECTION 1. Best Interest of the City of Raymond and Area to be annexed. That the annexation will be to the best interest of the City of Raymond, Minnesota, and of the territory affected.

SECTION 2. Abuts on City Limits. That the property above described abuts on the city limits, and is so conditioned as property to be subject to city government.

SECTION 3. Annexation. That the said property is hereby annexed to, and included within, the City of Raymond, Minnesota, as effectually as if it had originally been a part thereof.

SECTION 4. Effective Date. This ordinance shall be filed and shall take affect and be in full force and effect from and after filing a certificate thereof with the Minnesota Municipal Board, the County of Kandiyohi, Minnesota, the Town Clerk of the Township of Edwards, County of Kandiyohi, State of Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.




