ORDINANCE NO. 31, SECOND SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the city and is deemed to be urban or suburban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

Section 1. Territory annexed. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the platted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Lot 1, Block 1, Oakwood Addition and adjoining street rights-of-way;
Lots 9, 10, 13, 14, 15, 16, Crestwood Hills 2nd Addition and adjoining street rights-of-way;
Outlots 32, 33, 34, 45, 46, 48, and the North 34 feet of Outlot 47, Crestwood Hills 3rd Addition and adjoining street rights-of-way.

Section 2. Filing. The City Recorder is directed to file certified copies of this ordinance with the Minnesota Municipal Board, Austin Township Clerk, County Auditor, County Recorder, Secretary of State and Austin Utilities.




