ORDER

WHEREAS, the petition for annexation of certain land to the City of Sleepy Eye was filed with the Minnesota Municipal Board on October 3rd, 1980; and

WHEREAS, an objection to that petition for annexation was filed with the Minnesota Municipal Board by Home Township on December 30th, 1980; and

WHEREAS, a hearing was held on said petition for annexation of certain lands to the City of Sleepy Eye on April 1st, 1981 and continued to May 13th, 1981, and continued to August 26, 1981 and thereafter continued indefinitely; and

WHEREAS, the property owners, petitioners herein, have requested that the petitioners be allowed to withdraw said petition for annexation of certain land to the City of Sleepy Eye;

IT IS HEREBY ORDERED: That the above entitled petition is withdrawn and the Minnesota Municipal Board file on said petition is hereby closed without prejudice. The property description in said petition is described as follows:

PART OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of SECTION 31, TOWNSHIP 110 NORTH, RANGE 32 WEST, BROWN COUNTY, MINNESOTA, more particularly described as follows:

Beginning at a point formed by the intersection of the South line of Brackenridge Street S.W. and the West line of Seventh Street S.W. as platted in the City of Sleepy Eye, Brown County, Minnesota; thence South 00 degrees 00 minutes 12 seconds West along the West line of said Seventh Street S.W. a distance of 360.00 feet; thence South 89 degrees 37 minutes 12 seconds West a distance of 450.00 feet; thence North 00 degrees 00 minutes 12 seconds East a distance of 360.00 feet; thence North 89 degrees 37 minutes 12 seconds East a distance of 450.00 feet to the point of beginning and containing 3.72 acres.

IT IS FURTHER ORDERED: That the effective date of this order is February 5th, 1982.
