

ORDINANCE NO. 82-01

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF KANDIYOHI, A MUNICIPAL CORPORATION OF THE STATE OF MINNESOTA, TO INCLUDE CERTAIN LANDS NOT EXCEEDING 200 ACRES.

WHEREAS, a petition has been filed with the governing body of the City of Kandiyohi, a municipal corporation of the State of Minnesota, by the sole owners having an interest therein, to have certain real property hereinafter described included within the limits of the City of Kandiyohi, Minnesota, and

WHEREAS, it is proposed to annex by virtue hereof to the said City of Kandiyohi, said property, all of which property is in Kandiyohi County, State of Minnesota, and

WHEREAS, the said property to be annexed is legally described as follows, to-wit:

All that part of SE $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 10, Township 119, Range 34, lying South of the railroad right-of-way of Burlington Northern, Inc. (formerly Great Northern Railway Company), EXCEPTING THEREFROM the Easterly 204.5 feet thereof, AND ALSO excepting that part of said SE $\frac{1}{4}$ of NE $\frac{1}{4}$ lying Southeasterly of the center line of Trunk Highway No. 12, Kandiyohi County, Minnesota, subject to easement for public highway and all easements of record.

NOW, THEREFORE, the City Council of the City of Kandiyohi hereby determines, ordains and declares as follows:

SECTION 1. Best Interest of the City of Kandiyohi and Area to be annexed. That the annexation will be to the best interest of the City of Kandiyohi, Minnesota, and of the territory affected.

SECTION 2. Abuts on City Limits. That the property above described abuts on the city limits, and is so conditioned as property to be subject to city government.

SECTION 3. Annexation. That the said property is hereby annexed to, and included within, the City of Kandiyohi, Minnesota, as effectually as if it had originally been a part thereof.

SECTION 4. Effective Date. This ordinance shall be filed and shall take affect and be in full force and effect from and after


