ORDINANCE NO. 80, 2ND SERIES

AN ORDINANCE ANNEXING TO THE CITY OF ST. PETER NUMEROUS TRACTS OF LAND CONTAINING 380 ACRES OF LAND, MORE OR LESS, LOCATED IN SECTIONS 10 AND 15 OF TOWNSHIP 110 NORTH, RANGE 26 WEST, LE SUEUR COUNTY, MINNESOTA, AND SECTIONS 9 AND 10 OF TOWNSHIP 110 NORTH, RANGE 26 WEST, NICOLLET COUNTY, MINNESOTA, AND IN MCLEOD'S ADDITION TO TRAVERSE, NICOLLET COUNTY, MINNESOTA, AND IN THE PLAT OF TRAVERSE DES SIOUX, SOUTH OF SIBLEY STREET, NICOLLET COUNTY, MINNESOTA.

THE CITY COUNCIL OF THE CITY OF ST. PETER ORDAINS:

Section 1. The following described tracts of land containing 380 acres, more or less, unincorporated and owned by the City of St. Peter are hereby declared by the City Council to be annexed to the City pursuant to Minn. Stat. 414.033 which lands are deemed to be urban in character. The tracts of land are described as follows:

- A. All those parts and portion of Government Lot Six (6) in Section Ten (10) and of Government Lot Four (4) in Section Fifteen (15) lying westerly of the Minnesota River as the same now exists, all in Township One Hundred Ten (110) North, Range Twenty-six (26) West, Le Sueur County; and).
- B. All those parts and portion of Government Lot Five (5) in Section Ten (10) and the Northwest Quarter of the Northeast Quarter (NW¼ NE¼) in Section Fifteen (15), lying westerly of the Minnesota River as the same now exists, all in Township One Hundred Ten (110) North, Range Twenty-six (26) West, Le Sueur County; and,

All that part of the South 40.80 acres of Lot Seven (7), Section Ten (10), Township One Hundred Ten (110) North, Range Twenty-six (26) West, lying easterly of the easterly right-ofway line of U.S. 169. Said South 40.80 acres being platted into Blocks One (1) through Seventeen (17), inclusive and Block A of McLeod's Addition to Traverse, Nicollet County; and,

All of Government Lot Nine (9) and Government Lot Eight (8), EXCEPT the North 20 acres of Government Lot Eight (8), Section Ten (10), Township One Hundred Ten (110) North, Range Twenty-six (26) West, Nicollet County; and,

All of Government Lots Ten (10) and Eleven (11), the Southwest Quarter of the Northwest Quarter (SW½ NW½), the North 20 acres of Government Lot Seven (7), and the North 20 acres of Government Lot Eight (8), all in Section Ten (10), Township One Hundred Ten (110) North, Range Twenty-six (26) West, Nicollet County; and,

- F. All that part of Lots One (1) through Six (6), inclusive of Block One Hundred Six (106), Fractional Block One Hundred Seven (107), and Lots Six (6) and Seven (7) of Block One Hundred Eight (108) of Traverse Des Sioux, South of Sibley Street, lying easterly of the easterly right-of-way of U.S. 169, Nicollet County; and,
 - The following described tract lying easterly of the easterly right-of-way line of U.S. Highway 169, to-wit: Beginning at the southeasterly corner of Lot Six (6) of Block One Hundred Sixteen (116) on the north line of McCann Street in the Town of Traverse Des Sioux South of Sibley Street; thence southwesterly to a point where the west line of First or Main Street intersects the south line of McCann Street; thence westerly along said south line of McCann Street to the east line of Third Street; thence at right angles southerly along said east line of Third Street 510 feet; thence at right angles easterly 150 feet; thence at right angles southerly 150 feet to the north line of Rice Street; thence at right angles easterly along said north line of Rice Street 510 feet; thence at right angles southerly to the east line of Section Nine (9), Township One Hundred Ten (110) North, Range Twenty-six (26) West; thence North along said section line to a point where the north line of McCann Street extended intersects the said section line; thence westerly along the north line of McCann Street extended to the point of beginning; and,

All of Lots Four (4), Five (5), Six (6) and Seven (7) in Block 100 of the Town of Traverse des Sioux, South of Sibley Street, and that part of Lots Eight (8), Nine (9), Ten (10) and Eleven (11) in Block 100 lying westerly of the west right-of-way line of Trunk Highway No. 169; and,

- I. All that part of the right-of-way of U.S. Highway Number 169 lying within Government Lot Seven (7), Section Ten (10), Township One Hundred Ten (110) North, Range Twenty-six (26) West; and,
- J. All that part of the right-of-way of U.S. Highway Number 169 in Section Nine (9), Township One Hundred Ten (110) North, Range Twenty-six (26) West lying south of the north line of McCann Street in the Town of Traverse des Sioux south of Sibley Street.

Section 2. Annexation of these lands is in the best interest of the City of St. Peter.

Section 3. The corporate limits of the City of St. Peter are hereby extended to include the properties described in Section 1, and the same are hereby annexed to and included within the City as effectively as if it had originally been a part thereof.

Section 4. All the provisions of Chapter 1 of the St. Peter City Code are made a part hereof and applicable to this Ordinance.

Section 5. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Nicollet County Auditor, the Traverse Township Clerk, the Le Sueur County Auditor, and the Kasota Township Clerk.


Section 6. This Ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 5.
