
The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.

ORDINANCE NO. 214

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GLENWOOD TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

THE CITY COMMISSION OF THE CITY OF GLENWOOD DOES ORDAIN:

WHEREAS, a certain Petition dated November 2, 1981, requesting annexation of the territory hereinafter described was duly presented to the City Commission of the City of Glenwood on the 1st day of December, 1981; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is ten (10) acres, more or less, of unplatted land, no part of which is included within the limits of an incorporated city or burrough; and

WHEREAS, the Petition was signed by all owners of the territory hereinafter described; and

WHEREAS, no objections to the annexation have been received from the Glenwood Township Board, or from the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the City Limits of the City of Glenwood at the Northeasterly boundary thereof;

NOW, THEREFORE, The City Commission of the City of Glenwood, Minnesota, does ordain:

SECTION 1. The City Commission of the City of Glenwood hereby determines that the annexation of the territory hereinafter described will be to the best interests of the City and of the territory affected; that the territory described herein abuts upon the City Limits and is, or is about to become, urban or suburban in character; and that none of said territory is now included within the limits of any city or burrough.

SECTION 2. Territory annexed. The corporate limits of the City of Glenwood are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the City as effectually as it if had been originally a part thereof:

All that part of the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Seventeen (17), Township One Hundred Twenty-five (125), Range Thirty-seven (37), which is described and enclosed within the following boundary lines, to-wit:

Beginning at a point on the North line of said Section Seventeen (17), 189.76 feet North 89 degrees 36 minutes 55 seconds East from the Northwest corner of Section Seventeen (17), Township One Hundred Twenty-five (125), Range Thirty-seven (37);

Thence North 89 degrees 36 minutes 55 seconds East 825.74 feet to the West right-of-way line of the Soo Line Railroad;
Thence South 22 degrees 38 minutes 55 seconds East along said right-of-way line, 572.93 feet;
Thence South 51 degrees 18 minutes 55 seconds West 541.70 feet to the Easterly right-of-way line of T. H. 55;
Thence North 38 degrees 41 minutes 05 seconds West 225.72 feet;
Thence North 51 degrees 18 minutes 55 seconds East 25 feet;
Thence North 38 degrees 41 minutes 05 seconds West 740.54 feet to the point of beginning.

The above-described tract of land contains 10.0 acres, more or less.

SECTION 3. Filing. The City Clerk of the City of Glenwood is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk of the Township of Glenwood, and the Pope County Auditor.

SECTION 4. Effective Date. This Ordinance shall take effect upon its passage and publication and the filing of certified copies as directed in Section 3 hereof.
