ORDINANCE NO. 108

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF  
THE CITY OF ISANTI TO INCLUDE CERTAIN UNINCORPORATED  
TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE  
CITY LIMITS AND ABUTTING THEREON

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban or suburban in character,

NOW, THEREFORE, THE CITY OF ISANTI DOES ORDAIN:

Section 1. Territory Annexed. The corporate limits of the City of Isanti, Minnesota, are hereby extended to the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

All that part of the South Half (S 1/2) of Section Thirty (30), Township Thirty-five (35), Range Twenty-three (23), Isanti County, Minnesota, not previously included in the corporate limits of the City of Isanti, Minnesota.

Section 2. Filing. The City Clerk/Administrator is directed to file certified copies of this ordinance with the Secretary of State, the Isanti County Auditor, the Clerk of the Isanti Township Board of Supervisors, and the Minnesota Municipal Board.

Section 3. Effective Date of Annexation. This annexation shall be complete at such time as this ordinance becomes effective,

thirty days from the date of its publication in the official newspaper, the filing of certified copies as directed in Section 2, and approval by the Minnesota Municipal Board.

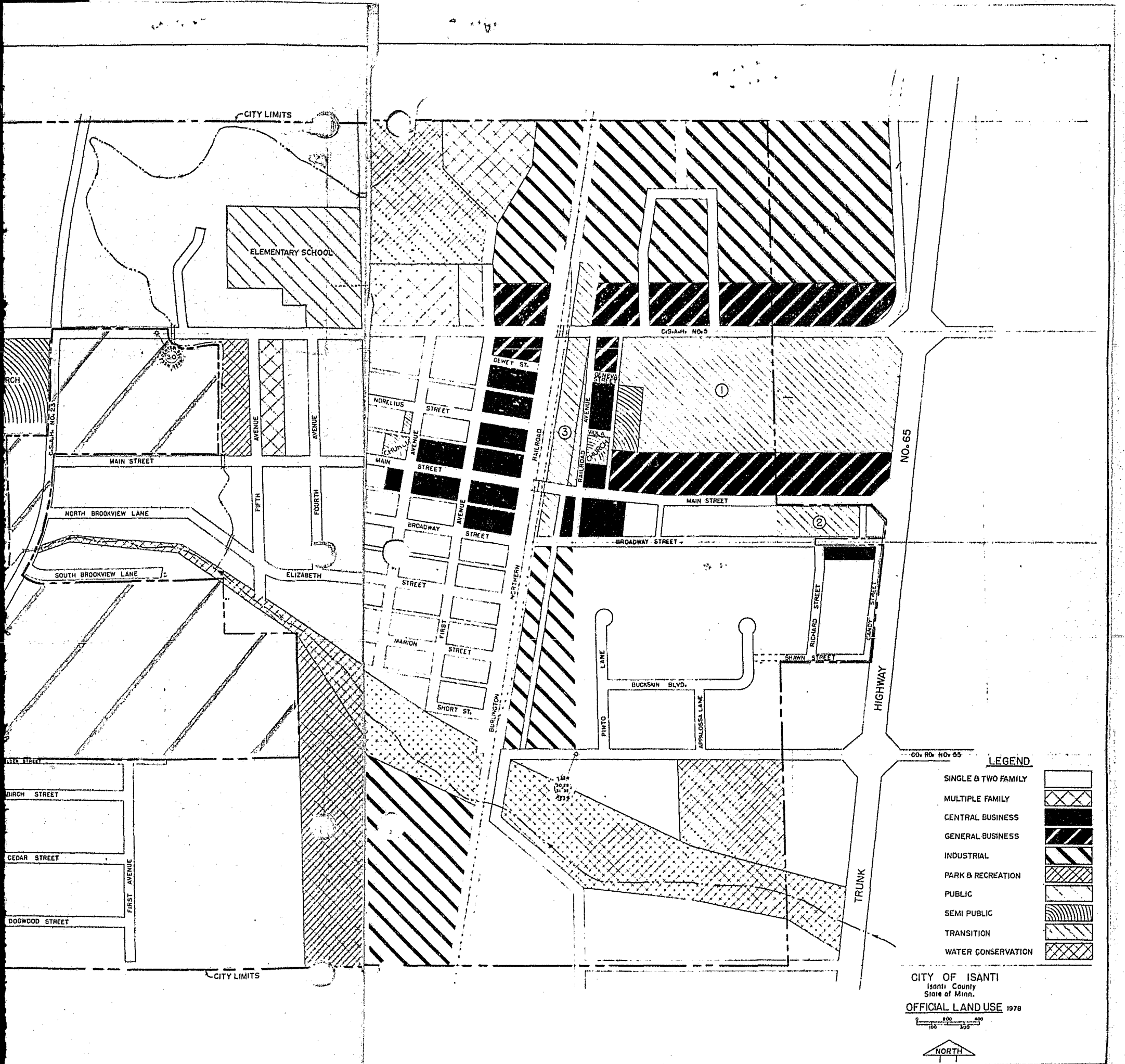
