ORDINANCE NUMBER 110 A

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF PIERZ TO
INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES AN AREA ABUTTING
UPON THE CITY LIMITS.

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council on the 8th day of March, 1982; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, the Town Board of Pierz Township has raised no objections to the annexation and has waived the time period in which to object, and there are no other municipalities whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the City Limits at the Southerly Boundary thereof;

The Council of the City of Pierz, Minnesota, ordains:

Section 1. The City Council hereby determines (1) That the territory described herein abuts upon the City Limits and is urban or suburban in character; and (2) That none of the territory is now included within the limits of any City.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof.

That part of the SW½ of SE½ of Section 8, Township 40, Range 30 Morrison County, Minnesota, described as follows: Commencing at the SW corner of said SW½ of SE½, thence North 00 degrees 00 minutes 08 seconds East, assumed bearing, 1327.9 feet along the West line of said SW½ of SE½ to the NW corner thereof, thence North 87 degrees 49 minutes 39 seconds East 539.00 feet along the North line of said SW½ of SE½, said line also being the South line of a public roadway to the point of beginning of the tract to be described; thence continuing North 87 degrees 49 minutes 39 seconds East 200 feet along said North line of the SW¼ of SE½, thence South 00 degrees 00 minutes 08 seconds West 150.00 feet, thence South 87 degrees 49 minutes 39 seconds West 200.00 feet, thence North 00 degrees 00 minutes 08 seconds East 150.00 feet to the point of beginning, said tract containing 0.68 acres, more or less.
