ORDINANCE NO. 17, THIRD SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS, TO INCLUDE CERTAIN UNPLATTED LANDS IN SECTION 31, TOWNSHIP 152 NORTH, RANGE 49 WEST OF THE FIFTH PRINCIPAL MERIDIAN, POLK COUNTY, MINNESOTA, NOT EXCEEDING 200 ACRES, WHICH TRACT CONTAINS FIVE (5) ACRES, MORE OR LESS.

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by Edith M. Hertweck, a single person, and Robert J. Hertweck and Kay J. Hertweck, husband and wife, being the owners of the land hereinafter described, to have such land included within the City Limits of the City of East Grand Forks, Minnesota, that copies of said petition were filed with the Minnesota Municipal Board, the Town Board of Grand Forks Township and the County Board of Polk County, Minnesota; that more than ninety (90) days have elapsed since such filings of said petition, and that no objections have been filed as is more fully shown by the records and files herein.

Section 2. That the tract of land being annexed is described as follows, to-wit:

A tract of land lying in Government Lot 4 and in the Southeast Quarter of the Southwest Quarter of Section 31, Township 152 North, Range 49 West of the 5th Principal Meridian, which tract is described as follows, to-wit:

Commencing at the southwest corner of Section 31, Township 152 North, Range 49 West of the 5th Principal Meridian and thence proceeding northerly, along the west line of said Section 31, for a distance of 116.00 feet; thence proceeding easterly, parallel with the south line of said Section 31, for a distance of 1224.00 feet to the true point of beginning; thence proceeding northerly, parallel with the aforesaid west line of Section 31, for a distance of 1127 feet more or less to an intersection with a line lying parallel with and 66.00 feet distant, southerly from the southerly right of way limit of U. S. Trunk Highway No. 2; thence proceeding easterly, along said line lying parallel with and 66.00 feet distant southerly from the southerly right of way limit of U. S. Trunk Highway No. 2, for a distance of 194.00 feet; thence proceeding southerly, parallel with the aforesaid west line of Section 31, for a distance of 1127 feet more or less to an intersection with a line lying parallel with and 116.00 feet distant northerly from the south line of the aforesaid Section 31; thence proceeding westerly, along said line lying parallel with and 116.00 feet distant northerly from the south line of Section 31, for a distance of 194.00 feet to the true point of beginning, said described tract being comprised of approximately 5 acres lying in Government Lot 4 and in the Southeast Quarter of the Southwest Quarter of Section 31, Township 152 North, Range 49 West of the 5th Principal Meridian, County of Polk, State of Minnesota.

Section 3. That the quantity of said land herein described is five (5) acres, more or less.

Section 4. That the City Council hereby determines:

1. That the quantity of land embraced within the foregoing description is less than 200 acres.

2. That the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected.

3. That the territory and land described above abuts the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government, and is now urban and suburban in character, to-wit: industrial park.

4. That the petition for annexation was signed by all of the owners of the land and real estate hereinabove described.

Section 5. The corporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the property described in Section 2, and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Board, the County Auditor, and Town Clerk and the Secretary of the State of Minnesota.

Section 7. This Ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 6, and be given the number 17, Third Series.


