ORDINANCE NO. 30

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ALBERTA TO INCLUDE CERTAIN UNINCORPORATED PROPERTY ABUTTING THE LIMITS OF THE CITY.

WHEREAS, a certain Petition dated the 31st day of December, 1979, requesting annexation of the territory hereinafter described, was duly presented to the Council on the 9th day of January, 1980, and

WHEREAS, the Petition was signed by the owner of the property, and

WHEREAS, no objections to the annexation have been received from the Town Board or the governing body of any municipality or county whose boundaries abut the land being annexed, and

WHEREAS, the land described in the Petition abuts upon the city limits at the South boundary thereof.

THE COUNCIL OF THE CITY OF ALBERTA ORDAINS:

SECTION 1: The City Council hereby determines

(1) that the territory described herein abuts upon the city limits and is about to become urban in character; and

(2) that none of the territory is now included within the limits of any city.

SECTION 2: The corporate limits of the City are hereby extended to include the unplatted land described as follows:

That part of Lot 4, County Auditor's Plat No. 1 in the South Half of Section 3, Township 124 North, Range 43 West, described as follows: Beginning at a point in the North line of the Southeast Quarter of said Section 3, said point being North 89°22'40" West 2230.05 feet from an iron monument at the East quarter corner of said Section 3; thence South 00°02'00" East 615.42 feet; thence along the north line of Second Avenue of Fougerson's Addition to the Village, now City, of Alberta and an easterly extension of said north line, North 89°50'24" West 989.05 feet to the centerline of County Road #9; thence, along said centerline, North 00°02'00" West 449.80 feet to the point of tangential curve to the right, having a radius of 954.93 feet, a central angle of 10°27'46"; thence along said curve an arc distance of 174.38 feet to a point in the north line of said Southwest Quarter; thence South 89°22'40" East 973.23 feet to the point of beginning. Subject to the right of way of County Road #9 and containing 14.04 acres, more or less.

and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof.

SECTION 3: The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk of the Township of Scott and the County Auditor of Stevens County.

SECTION 4: This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3 and approval of the Ordinance by the Minnesota Municipal Board.
