ORDINANCE NO. 1980-/

AN ORDINANCE EXTENDING THE CORPORATE LIMITS

OF THE CITY OF ALBERTVILLE, MINNESOTA,

TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED

LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING

UPON THE CITY LIMITS OF ALBERTVILLE

WHEREAS, a certain Petition dated January 30, 1980, requesting annexation of the territory hereinafter described was duly presented to the Council on the 19 day of 30, and

WHEREAS, the Petition was signed by all owners of said territory; and

WHEREAS, the Town Board of Otsego Township has executed a Waiver by which they state that Otsego Township has no objection to the annexation of the hereinafter described territory to the City of Albertville;

THE COUNCIL OF THE CITY OF ALBERTVILLE, MINNESOTA, ORDAINS:

Section 1. The City Council hereby determines (1) that the
territory described herein abuts upon the City limits and is urban
or suburban in character; and (2) that none of the territory is
now included within the limits of any city.

Section 2. The corporate limits of the City are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

Section 3. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Otsego Town Clerk, and the Wright County Auditor.

Section 4. This Ordinance takes effect upon its passage and its publication by filing of certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.

Adopted by the Council this 19x1day of 2eb., 1980, as amended by the Council, to correct legal description, on April 7, 1980.

The South 60 rods of the Southeast Quarter of Southeast Quarter, all in Section 36, Township 121, Range 24 lying and being South and East of the so called Otsego Road over and across said land, excepting therefrom the East 20 acres thereof and also except lands acquired by the State of Minnesota for highway purposes as described in final certificate recorded in Book 229 of Deeds, Pages 40-89 (Parcel 337) and also excepting lands acquired by the State of Minnesota in Warranty Deed recorded in Book 246 of Deeds, Page 395-397.
