ORDINANCE NO. 081-118

An ordinance amending the City Code concerning City Boundaries and changes thereto by annexation.

THE CITY COUNCIL OF THE CITY OF FARMINGTON ORDAINS AS FOLLOWS:

- SECTION I Title 1, Chapter 11, Section 2(A) of the City Code is hereby amended by adding the following:
 - "14. Upon receipt of petition for annexation of LaVerne and Steven Frandrup, Contract for Deed buyers, dated September 4, 1981 and upon receipt of approval and waiver by the Empire Town Board dated September 9, 1981 under Minnesota Municipal Board Docket No. A3854, the following described lands are hereby annexed to and become a part of the municipality of Farmington:

DESCRIPTION

That part of the South Half of the Southeast Quarter (S½ of SE¾) of Section Thirty (30), Township One Hundred Fourteen (114), Range Nineteen (19); commencing 40' North of the Northwest corner of Lot Five (5), Block Two (2), Bung's Addition to the City of Farmington; thence North 200 feet; thence East 80 feet; thence South 200 feet; thence West 80 feet to the place of beginning, subject to existing easements.
