

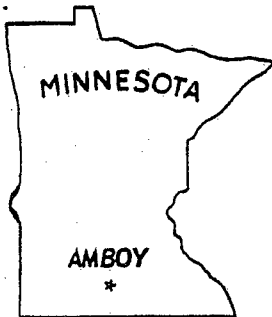

ORDINANCE NO. 88

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AMBOY TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

Whereas, a certain petition dated July 6, 1981, requesting annexation of the territory hereinafter described was duly presented to the council on the 6th day of July, 1981; and

Whereas, the quantity of land embraced within the area described in the petition and bounded as described is approximately 1.5 acres of unplatted land, no part of which is included within the limits of an incorporated city; and

Whereas, the petition was signed by all owners; and

Whereas, no objections to the annexation have been received from the town board, the county board of the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

Whereas, the land described in the petition abuts upon the city limits at the north and east boundaries thereof;

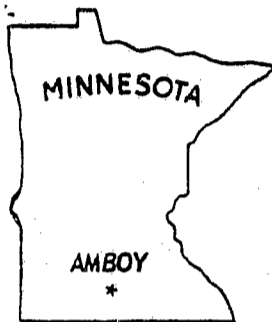
The Council of the City of Amboy, Minnesota, ordains:

SECTION 1. The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city or borough.

SECTION 2. TERRITORY ANNEXED. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof;

A tract of land in the Southwest Quarter of the Northwest Quarter of Section 23, Township 105 North, Range 28 West in Blue Earth County, Minnesota, described as follows:

Commencing at the Southwest Corner of Stevens Second Addition according to the plat on file and of record in the Office of the Blue Earth County Recorder thence North 90°.00' West, assumed bearing, along the Westerly extension of the Southerly line of said Stevens Second Addition 330'.00 feet thence North 0°.0' West 187.22 feet to the Southerly line of South Street as platted in Stevens Subdivision according to the plat on file and of record in the Office of the Blue Earth County Recorder thence Easterly along the Southerly line of said South Street

to the Northwest Corner of said Stevens Second Addition thence Southerly along the Westerly line of said Stevens Second Addition to the point of beginning.

SECTION 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

SECTION 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
