ORDINANCE NUMBER 27

AN ORDINANCE ANNEXING ROSIN LAKE ESTATES TO THE CITY OF BARRETT

Whereas a Petition dated May 31, 1979 from Virgil Rosin and Kathleen F. Rosin has been filed pursuant to Minnesota Statutes Section 414.033 Subd. 5 for annexation of the following described real estate to the City of Barrett:

Block 1, Lot 1 and Block 2, Lots 1 through 8 and the road, drainage and utility easement of Rosin Lake Estates according to the plat thereof of record and on file with the Grant County Recorder, also described as beginning at the point of intersection with the south line of said Government Lot 2, (East/West quarter section line of said Section 7) and the easterly boundary line of Recreation Camp a platted Subdivision, on file at the County Recorder's Office, Grant County, Minnesota; thence South 89°52'40" East 106.23 feet along the quarter section line to the westerly right of way line of County Highway number 10 as now located and constructed; thence North 27°15'00" East 871.51 feet along said right of way line; thence along a tangential curve, concave to the east, radius 2898.06 feet, central angle 01°44'16", for a distance of 87.90 feet along said right of way line; thence north 59°38'40" West 241.00 feet more or less to the shore of Barrett Lake; thence Southwesterly along the lake approximately 782.00 feet, a point of intersection with the northerly extension of the easterly line of said Recreation Camp; thence south 15°39'14" East 358.64 feet more or less to the point of beginning; and

Whereas the Petitioners are all of the property owners of the land proposed to be annexed; and

Whereas the proposed territory abuts the municipal corporation, is or is about to become urban or suburban in character, is not included in the boundaries of any other incorporated municipality and it being in the best interest of the City of Barrett and of the territory affected:

Be it ordained by the City Council of Barrett, Minnesota as follows:

Section 1.


The following described real estate, known as Rosin Lake Estates is and shall be annexed to the City of Barrett:


Section 2.
