ORDINANCE ANNEXING CERTAIN UNPLATTED LAND  
TO THE CITY OF COLD SPRING, STEARNS COUNTY, MINNESOTA

WHEREAS, the corporate borders of the City of Cold Spring abut the certain parcels of property on more than sixty (60%) percent of said properties perimeter, said property being less than forty (40) acres, and legally described as follows:

That part of Section Twenty-Two (22), Township One Hundred Twenty-Three (123) North, Range Thirty (30) West, Stearns County, Minnesota, described as follows: That part of the West half of the Northwest Quarter (W $\frac{1}{2}$  NW $\frac{1}{4}$ ) and of the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$  SW $\frac{1}{4}$ ) of Section Twenty-Two (22), Township One Hundred Twenty-Three (123) North, of Range Thirty (30) West lying North of the northwesterly right-of-way line of State Trunk Highway No. 23 as now located and westerly of the West line of Wenner's Sub-division and Wenner's Addition and Replat (said West line to be extended South across the Burlington Northern Railroad right-of-way to the northwesterly right-of-way line of State Trunk Highway No. 23 and extended North to the center line of County Aid Road No. 158); and southerly of the center line of County Aid Road No. 158.

and;

WHEREAS, the City Council for the City of Cold Spring desires to annex said property to the City and include it within its corporate limits, and;

WHEREAS, it is the determination of the City Council that said property is urban or suburban in character and will best serve the interests of the City of Cold Spring if included within its corporate limits.

NOW, THEREFORE, the City Council for the City of Cold Spring, Minnesota, does hereby declare and ordain:

1. That the corporate limits of the City of Cold Spring, Stearns County, Minnesota, be and they hereby are extended to include that certain real estate herein before described and the same is hereby annexed and included in the City of Cold Spring as effectually as if it had originally been a part thereof.

2. That the City Clerk is hereby authorized and directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Clerk for the Town of Wakefield, the Stearns County Auditor, and the Secretary of State for the State of Minnesota.

3. This ordinance shall become effective from and after its

passage, publication and filing of certified copies as herein before directed.
