ORDINANCE NO. 45:01

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF OSAKIS TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, A certain petition, dated the 30th day of December, 1976, requesting annexation of the territory hereinafter described, was duly presented to the City Council on the 3rd day of January, 1977, and

WHEREAS, The quantity of land embraced within the area described in the petition and bounded as described is less than two hundred (200) acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, The petition was signed by all of the owners of said property, and

WHEREAS, No objections to the annexation have been received from the town board, the county board or the governing body of any municipality whose boundaries abut upon the land to be annexed, and

WHEREAS, A copy of said petition was filed with the Municipal Commission of the State of Minnesota, the County Auditor of Douglas County, the City Clerk of the City of Osakis, the Clerk of the Osakis Township Board, on December 21, 1976, and

WHEREAS, The land described in the petition abuts upon the city limits at the south boundary thereof,

The City Council of the City of Osakis, Minnesota, ordains:

Section 1: The City Council hereby determines:

- a. That the annexation will be in the best interests of the City, and of the territory affected.
- b. That the territory described herein abuts the city limits and is urban or suburban in character.

- c. That none of the territory is now included within the limits of any city, village or borough.

Section 2: Territory Annexed:

The corporate limits of the City of Osakis are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included in the City as effectually as if it had originally been a part thereof:

That part of the Southeast Quarter of the Northeast Quarter ($SE\frac{1}{4}$ of $NE\frac{1}{4}$) of Section-Thirty-six (36), Township One Hundred Twenty-eight (128), Range Thirty-six (36), described as follows, to-wit: Commencing at the East Quarter corner of said Section 36, thence North $00^{\circ}39'$ East, 650.2 ft. on and along the East line of said Section 36 to the point of beginning (of this exception) thence South $89^{\circ}43'$ West, 715.0 ft., thence North $03^{\circ}25'$ West, 404.3 ft.; thence North $52^{\circ}15'$ West, 402.4 ft.; thence North $89^{\circ}49'$ East, 1064.7 ft. on and along the north $1/16$ line of said Section 36; thence South $00^{\circ}39'$ West 650.1 ft. on and along said East section line to the point of beginning, County of Douglas, State of Minnesota, containing approximately twelve (12) acres, more or less.

Section 3: Filing:

The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor, Douglas County, Minnesota, the Osakis Township Clerk, and the Secretary of State for the State of Minnesota.


Section 4: Effective Date of this Ordinance takes effect upon its passage and publication and upon the filing of the certified copies of the Ordinance as directed in Section 3.
