

## ORDINANCE NO. 123

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF PERHAM TO INCLUDE CERTAIN UNINCORPORATED PLATTED LANDS NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated April 26, 1982, requesting annexation of the territory hereinafter described was duly presented to the council on the 28th day of April, 1982; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 13.85 acres, more or less, of platted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by John W. Swenson, the owner of the abutting property to be annexed; and

WHEREAS, no objections to the annexation have been received from the town board, the county board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a consent by the Perham Township board was issued to waive the time limitations involved and to approve the annexation; and

WHEREAS, the land described in the petition abuts upon the city limits at the west boundary thereof;

NOW THEREFORE, The Council of the City of Perham, Minnesota, ordains:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is or is about to become urban or suburban and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. TERRITORY ANNEXED. The corporate limits of the city are hereby extended to include the platted land described as follows and the same is hereby annexed to and included with the city as affectually as if it had originally been a part thereof:

That part of the Southwest ½ of Section 15, Township 136, Range 39, Otter Tail County, Minnesota, described as follows: Commencing at the northeast corner of said Southwest ½; thence on an assumed bearing of South 0° 34' 17" West on the easterly line of said Southwest ½ for a distance of 245.00 feet to point of beginning of area to be described; thence continuing Southerly on said quarter section line and on a bearing of South 0° 34' 17" West

Section 3. <u>FILING</u>. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. EFFECTIVE DATE. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
