

IN THE MATTER OF THE APPLICATION OF THE HONORABLE CHARLES W. KENNEDY, JUDGE OF THE DISTRICT COURT, SEVENTH JUDICIAL DISTRICT, STATE OF MINNESOTA, FOR AN EXTENSION OF THE TERM OF THE SAID CHARLES W. KENNEDY UP TO AND INCLUDING APRIL 30, 1983, PURSUANT TO MINNESOTA STATUTES SECTION 490.124, SUBDIVISION 2, AND FOR RETIREMENT ON APRIL 30, 1983, PURSUANT TO MINNESOTA STATUTES SECTION 490.124, SUBDIVISION 2.

WHEREAS, the Honorable Charles W. Kennedy, Judge of District Court for the Seventh Judicial District, State of Minnesota, having made application to the undersigned Governor Albert H. Quie, in a letter dated May 3, 1982, for extension of his present term until April 30, 1983, and for full retirement at the close of business on said date; and

WHEREAS, the said Charles W. Kennedy has served as District Court Judge for the Seventh Judicial District since February 20, 1962; and

WHEREAS, the said Charles W. Kennedy will attain the age of 70 years on April 13, 1983, thus reaching his "mandatory retirement date" in accordance with the provisions of Minnesota Statutes Section 490.121, Subdivision 12 on April 30, 1983; and


WHEREAS, Minnesota Statutes Section 490.124, Subdivision 2 requires the Governor to make a written order extending such term of office and accepting such requests for retirement; and

WHEREAS, the necessary legal requirements have or will have been met for such extension of term and retirement on the close of business on April 30, 1983.

NOW, THEREFORE, I, ALBERT H. QUIE, Governor of the State of Minnesota, acting pursuant to the aforementioned statutes, do hereby order that the present term of office for the Honorable Charles W. Kennedy be, and it hereby is, extended to April 30, 1983, and I further order and direct the retirement of the Honorable Charles W. Kennedy to become effective at the close of business on April 30, 1983. He shall become entitled thereafter to retirement compensation as provided under the provisions of Minnesota Statutes Chapter 490.


I hereby direct that this order be filed in the office of the Secretary of State of the State of Minnesota.


