

Proclamation

WHEREAS: THE AMERICAN BUSINESS WOMEN'S ASSOCIATION IS ONE OF THE NATION'S FASTEST GROWING AND MOST INFLUENTIAL ORGANIZATIONS; AND

- WHEREAS: THE OBJECTIVE OF ABWA IS TO PROMOTE THE PROFESSIONAL, EDUCATIONAL, CULTURAL, AND SOCIAL ADVANCEMENT OF BUSINESS WOMEN BY UNITING THEM NATIONALLY FOR TRAINING DESIGNED TO MAKE THEM MORE EFFICIENT, MORE CONSIDERATE, AND MORE COOPERATIVE TOWARD THEIR WORK, THEIR EMPLOYERS, AND THEIR EMPLOYERS' CUSTOMERS, THEREBY INCREASING THEIR EARNING ABILITY, SUCCESS AND HAPPINESS; AND
- WHEREAS: ABWA HAS OVER 2,000 CHAPTERS, MEMBERS IN ALL 50 STATES AND PUERTO RICO, AND AN ACTIVE MEMBERSHIP EXCEEDING 105,000; AND
- WHEREAS: LOCAL CHAPTERS SPONSOR SCHOLARSHIPS FOR DESERVING WOMEN STUDENTS AND FOR BUSINESS WOMEN DESIRING TO CONTINUE THEIR EDUCATION; AND
- WHEREAS: Local chapters have annually awarded over \$1,000,000 in scholarships, and its national educational fund, known as the Stephen Bufton Memorial Educational Fund, has awarded additional scholarships exceeding \$2,000,000 since its inception;
