ORDINANCE NO. 44, SECOND SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the city and is deemed to be urban or suburban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

Section 1. Territory annexed. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the platted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Commencing at the northeast corner of the northwest 1/4 of Section 34, Township 103 North, Range 18 West, Mower County, Minnesota, thence westerly along the north line of said 1/4 section a distance of 283 feet thence southerly on a line parallel to the east line of said 1/4 section a distance of 100 feet to the point of beginning thence continuing southerly on the same line a distance of 50 feet thence easterly 100 feet on a line parallel to the north line of said 1/4 section thence northerly 50 feet on a line parallel to the east line of said 1/4 section thence westerly 100 feet to the point of beginning.

Section 2. Filing. The City Recorder is directed to file certified copies of this ordinance with the Minnesota Municipal Board, Lansing Township Clerk, County Auditor, County Recorder, Secretary of State and Austin Utilities.



Passed by a vote of Yeas and Nays this 21st day of June, 1982.



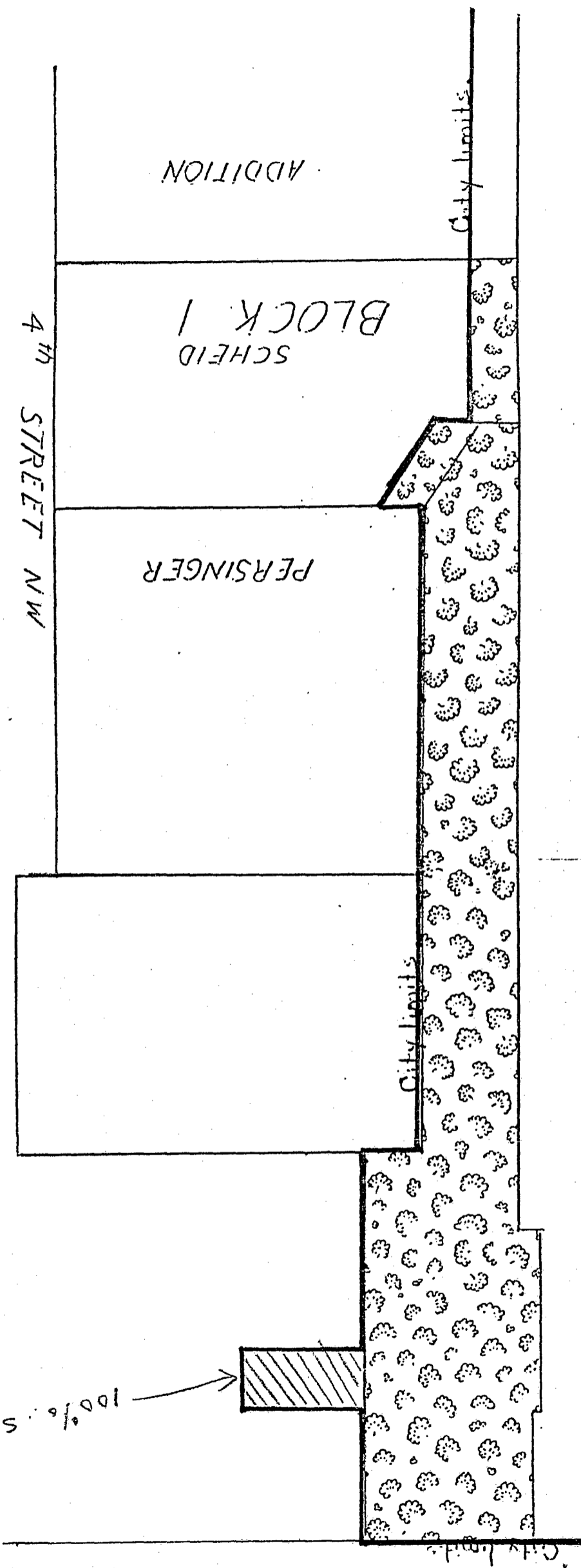
