ORDINANCE NO. THIRD SERIES

ORDINANCE DECLARING THE ANNEXATION TO THE CITY OF NORTH MANKATO OF THE EXTENSION OF LOOKOUT DRIVE AND HOWARD DRIVE BETWEEN LOOKOUT DRIVE AND THE CURRENT CORPORATE LIMITS.

The Common Council of the City of North Mankato, Minnesota, does ordain as follows:

Section 1. The following tract of land, which abuts upon the city limits, which is or about to become urban or suburban in character, and which consists of dedicated conveyances for street purposes to the City of North Mankato, Minnesota, which land is in the County of Nicollet, State of Minnesota and is described as follows:

The North 33 feet of the Southwest Quarter of the Southwest Quarter of Section 2, Township 108, Range 27, and

The North 33 feet of the Southeast Quarter of the Southeast Quarter of Section 3, Township 108, Range 27, excepting the right of way of T.H. 14, and

The West 50 feet of the East 83 feet of the South 33 feet of the Northwest Quarter of the Southeast Quarter of Section 3, Township 108, Range 27, and

The East 83 feet of the North 33 feet of the Southwest Quarter of the Southeast Quarter of Section 3, Township 108, Range 27, excepting the right of way of T.H. 14, and

The South 33 feet and the West 33 feet of the West Half of the Northeast Quarter of the Southeast Quarter of Section 3-108-27. Also, the West 33 feet of the Southeast Quarter of the Northeast Quarter of Section 3, Township 108, Range 27, and

The South 33 feet of the East Half of the Northeast Quarter of the Southeast Quarter of Section 3-108-27. Also the South 33 feet of the Northwest Quarter of the Southwest Quarter of Section 2-108-27,

is hereby annexed and declared to be part of the City of North Mankato and to be included in the corporate limits thereof.

Section. 2. This ordinance shall take effect from and after its date of passage, publication and approval by the State Municipal Board.
