REORGANIZATION ORDER NO. 87

Pursuant to Minnesota Statutes, Section 16.125, the following Amendment to Reorganization Order No. 87 is made with the prior approval of the Governor.

For the 1982-83 biennium, two-thirds of the total annual funding for the County Assistance Forestry Program shall be provided by the Iron Range Resources and Rehabilitation Board, and one-third of the funding shall be provided by the Department of Natural Resources. Funds shall be transferred to the Department of Natural Resources as soon as possible after July 1 of each fiscal year.

This amendment shall expire on June 30,1983 , and nothing herein shall be construed to bind the Iron Range Resources and Rehabilitation Board to funding any portion of this program in future biennia.

All other terms of Reorganization Order No. 87 shall remain unchanged.

Douglas Lodge and cabins, Itasca State Park

WHEREAS, the Division of Parks and Recreation desires to promote the use of Douglas Lodge and cabin facilities at Itasca State Park during the end of the tourist season when visitation historically has been low, and

WHEREAS, travel agencies commonly offer promotional packages similar to that outlined below,

NOW THEREFORE, the Division of Parks and Recreation is authorized to offer a promotional package through certified travel agencies for Douglas Lodge and other cabin facilities at Itasca State Park as follows:

1) The term of this promotion is from August 22 through September 30, 1982. .
2) All visitors must be registered in advance through a certified travel agency and will pay a reduced unit rental rate on Spnday through Thursday as listed below, provided visitors rent a unit a minimbm of two days to qualify.
3) Each certified travel agency which registers visitors pursuant to this promotion shall collect full payment in advance at the rates specified below for each day reserved and shall transmit $90 \%$ of the total rental charge to Douglas Lodge, Itasca State Park, Lake Itasca, $\mathbb{N N}$ 56460, retaining the remaining $10 \%$ as consideration for its services. Such agencies shall also inmediately inform Douglas Lodge of the reservation providing the name, address, number in party and pertinent payment information. The provisions of this paragraph apply only to units for which the certified travel agency has confirmed reservation dates.

Promotional Rental Charges, Fees, and Supplements
Minimum rates per accommodation are quoted below. Each additional adult will be charged at the rate of $\$ 3.92$ per day and each child under 12 years of age at the rate of \$1.96 per day. Extra cots are not available. All accommodations, unless otherwise stated, have private bath.
