ORDINANCE NO. 536

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MOORNEAD TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain Petition requesting annexation of the land hereinafter described, has been duly presented to and received by the City Council of the City of Moorhead; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described, is less than two hundred (200) acres of unplatted land, no part of which is included within the limits of an incorporated City, Village, or borough; and

WHEREAS, the Petition was signed by all of the owners of the real estate involved; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality who's boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the City limits that a portion of its existing boundaries;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Moorhead, as follows:

Section 1. The City Council does hereby determine (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. TERRITORY ANNEXED. The corporate limits of the City of Moorhead, Minnesota, are hereby extended to include the unplatted territory described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof, which territory now is and has heretofore been bordered on at least sixty percent (60%) of its exterior boundary by territory already included within the City limits:

A certain tract of land located in the Northwest One-Quarter of Section 20, Township 139 North, Range 48 West of the Fifth Principal Meridian, Clay County, Minnesota; that the exterior boundary of said tract of land is more particularly described as follows: Beginning at a Point which lies on the East-West One-Quarter line in Section 20, Township 139 North, Range 48 West of the Fifth Principal Meridian, said Point of Beginning being located on the West Right-of-Way line of Trunk Highway 75 and 75.00 feet West of the Center of said Section 20; thence North along the said West Right-of-Way line a distance of 466.70 feet to a Point of Intersection with the South line of Block 9 of the Brookdale South Addition to the City of Moorhead, Minnesota; thence West along the said South line of Block 9 a distance of 836.75 feet; thence South along a line which is parallel to the West Rightof Way line of Trunk Highway 75 a distance of 466.70 feet, more or less, to a Point of Intersection with the aforementioned East-West One Quarter line of said Section 20; thence East along said East-West One-Quarter line a distance of 836.75 feet, more or less, to the Point of Beginning; that said tract of land contains 8.965 acres, more or less, including the road easement along and parallel to the South Line.

Section 3. FILING. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesita Municipal Commission, the Secretary of State, and the County Auditor for Clay County.

Section 4. EFFECTIVE DATE. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
