



## Proclamation

WHEREAS: "CAPITOL FOR A DAY" IS A PROGRAM INITIATED BY THE GOVERNOR'S OFFICE AND A SELECTED CITY OF MINNESOTA IN WHICH THE GOVERNOR AND OTHER STATE LEADERS, IN COOPERATION WITH LOCAL LEADERS, COME TO THE CITY FOR ONE DAY TO INTERACT WITH THE PEOPLE ON STATE AND AREA ISSUES; AND

WHEREAS: "CAPITOL FOR A DAY" IS AN OPPORTUNITY FOR THE GOVERNOR, LT. GOVERNOR, AND INVITED STATE OFFICIALS TO LISTEN TO THE PEOPLE IN THEIR LOCAL SETTING, THEREBY STRENGTHENING COMMUNICATION BETWEEN THE PEOPLE AND THE STATE'S LEADERS; AND

WHEREAS: AN INVITATION FROM MAYOR BOB CARLSON TO DESIGNATE THIEF RIVER FALLS AS "CAPITOL FOR A DAY" ON SEPTEMBER 15, 1982 HAS BEEN ACCEPTED; AND

WHEREAS: "CAPITOL FOR A DAY" - THIEF RIVER FALLS WILL FOCUS ON THE SPECIAL CONCERNS OF THIS COMMUNITY WHICH REPRESENTS A PLEASING BLEND OF CITY SOPHISTICATION AND COUNTRY SERENITY WITH A SUCCESSFUL AGRICULTURAL ATMOSPHERE AS WELL AS A THRIVING BUSINESS COMMUNITY; AND

WHEREAS: THIEF RIVER FALLS IS THE 22ND CITY IN MINNESOTA TO HOST "CAPITOL FOR A DAY";

NOW, THEREFORE, I, ALBERT H. QUIE, GOVERNOR OF THE STATE OF MINNESOTA, DO HEREBY PROCLAIM SEPTEMBER 15, 1982 TO BE

"CAPITOL FOR A DAY" IN THIEF RIVER FALLS

MINNESOTA, AND HAVE ASKED LIEUTENANT GOVERNOR LOU WANGBERG TO PREPARE THIS PROCLAMATION FOR MY SIGNATURE AND DISSEMINATE THE SAME.

IN WITNESS WHEREOF, WE HAVE HEREUNTO SET OUR HANDS AND CAUSED THE GREAT SEAL OF THE STATE OF MINNESOTA TO BE AFFIXED THIS FIFTEENTH DAY OF SEPTEMBER IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND EIGHTY-TWO AND OF THE STATE THE ONE HUNDRED TWENTY-FOURTH.
