AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF DELANO TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated September 7, 1982, requesting annexation of the territory hereinafter described was duly presented to the council on the 7th day of September, 1982; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the Town Board of Franklin Township or the govering body of any municipality whose boundaries abut upon the boundaries of the land to be annexed;

WHEREAS, the Town Board of Franklin Township has waived the right to object and has waived the 90 days before the city ordinance can be adopted; and

WHEREAS, the land described in the petition abuts upon the city limits at the Northern boundary thereof;

THE COUNCIL OF THE CITY OF DELANO, MINNESOTA, ORDAINS:

Section 1. The city council hereby determines (1) that the territory described herein abuts upon the city limits and is or is about to become urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described in Exhibit A attached hereto and made a part hereof and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof.

Section 3, Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.

Commencing at the northeast corner of said S½ of the NW½; thence on an assumed bearing of North 89° 22' 45" West along the north line of said S½ of the NW½, a distance of 131.57 feet to the actual point of beginning of the land to be described; thence South 39° 27' 21" West, a distance of 89.43 feet; thence South 34° 46' 21" West, a distance of 543.29 feet; thence South 35° 38' 06" West, a distance of 40.28 feet; thence North 64° 34' 28" West, a distance of 126.91 feet; thence northwesterly along a tangential curve concave to the northeast having a radius of 265.32 feet and a central angle of 22° 58' 09", a distance of 106.36 feet; thence North 41° 36' 19" West tangent to said curve, a distance of 20.00 feet; thence South 48° 23' 41" West, a distance of 291.89 feet; thence southwesterly along a tangential curve concave to the northwest having a radius of 526.76 feet and a central angle of 7° 06' 56", a distance of 65.42 feet; thence North 31° 13' 29" West not tangent to said curve, a distance of 169.14 feet; thence northerly along a tangential curve concave to the east having a radius of 513.99 feet and a central angle of 32' 25' 0/", a distance of 177.66 feet; thence North 1° 11' 38" East tangent to said curve, a distance of 43.94 feet; thence North 1° 48' 23" West, a distance of 115.91 feet; thence North 1° 11' 38" East, a distance of 190.00 feet to the north line of said S½ of the NW½; thence South 89° 22' 45" Fest along said north line, a distance of 1028.21 feet to point of beginning. Containing 10.023 acres.
