A RESOLUTION CERTIFYING CANVASS OF
MUNICIPAL ELECTION ON PROPOSITIONS #1 AND #2

WHEREAS, the City Council met in a special session this date for the purpose of fulfilling obligations set down by the Charter and did travel to each election district within the City and canvassed results of the municipal election conducted November 2, 1982; now, therefore,

THE CITY OF ALBERT LEA RESOLVES:

Sec. 1. As a result of each canvass, the Council finds as follows:

- A. That the number of votes cast was 7,973.
- B. That the ballots cast for each proposition were as follows:

PROPOSITION #1

"Shall the City Council for the City of Albert Lea amend the City Code to allow establishments to which on-sale licenses have been issued or hereafter may be issued for the sale of intoxicating liquors which are hotels, restaurants, or clubs as defined in Minnesota Statutes, Section 340.07, and which have facilities for serving not less than 125 guests at one time, to serve intoxicating liquors between the hours of 12:00 o'clock noon and 12:00 o'clock midnight on Sundays in conjunction with the serving of food?"

PROPOSITION #2

"Shall the City Council for the City of Albert Lea adopt a resolution urging the government of the United States to propose to the government of the Soviet Union a mutual freeze on the testing, production and deployment of nuclear weapons, missiles, and new aircraft designed primarily to deliver nuclear weapons. This would be an essential, verifiable first step toward lessening the risk of nuclear war and reducing the nuclear arsenals while releasing funds and resources to satisfy human needs."
